

**FIRST ENGROSSMENT  
with Senate Amendments  
ENGROSSED HOUSE BILL NO. 1025**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 veterans' affairs; to provide for a report; and to provide an exemption.

**3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the department of veterans' affairs for the purpose of defraying the expenses of  
8 the department of veterans' affairs, for the biennium beginning July 1, 2019, and ending  
9 June 30, 2021, as follows:

22 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**  
23 **SIXTY-SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time

1 funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the  
2 2019-21 biennium one-time funding items included in the appropriation in section 1 of this Act:

10 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget  
11 for the 2021-23 biennium. The department of veterans' affairs shall report to the appropriations  
12 committees of the sixty-seventh legislative assembly on the use of this one-time funding for the  
13 biennium beginning July 1, 2019, and ending June 30, 2021.

14 **SECTION 3. EXEMPTION.** The amount of \$50,000 appropriated for the posttraumatic  
15 stress disorder service dogs program in section 1 of chapter 49 of the 2017 Session Laws is not  
16 subject to section 54-44.1-11 and any unexpended funds from this program are available for the  
17 program during the biennium beginning July 1, 2019, and ending June 30, 2021.

18 **SECTION 4. ESTIMATED INCOME - VETERANS' HOME CEMETERY FUNDING.** The  
19 estimated income line item in section 1 of this Act includes \$291,500, of which \$265,000 is from  
20 federal funds and \$26,500 is from the Melvin Norgard memorial fund, for the purpose of  
21 repairing and maintaining the cemetery located on the veterans' home campus during the  
22 biennium beginning July 1, 2019, and ending June 30, 2021. This funding is considered a  
23 one-time funding item.
