## ENGROSSED SENATE BILL NO. 2004

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state auditor; to  
2 amend and reenact section 54-10-10 of the North Dakota Century Code, relating to the salary of  
3 the state auditor; to provide for a report; and to declare an emergency.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
8 other income, to the state auditor for the purpose of defraying the expenses of the state auditor,  
9 for the biennium beginning July 1, 2019, and ending June 30, 2021, as follows:

20 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO SIXTY-**  
21 **SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the 2019-21 biennium  
22 one-time funding items included in the appropriation in section 1 of this Act:

4 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget  
5 for the 2021-23 biennium. The state auditor shall report to the appropriations committees of the  
6 sixty-seventh legislative assembly on the use of this one-time funding for the biennium  
7 beginning July 1, 2019, and ending June 30, 2021.

8 **SECTION 3. AMENDMENT.** Section 54-10-10 of the North Dakota Century Code is  
9 amended and reenacted as follows:

10 **54-10-10. Salary of state auditor.**

11 The annual salary of the state auditor is ~~one hundred two thousand six hundred eighty-nine~~  
12 ~~dollars through June 30, 2016, and one hundred five thousand seven hundred seventy dollars~~  
13 ~~thereafter~~ one hundred seven thousand eight hundred eighty-five dollars through June 30, 2020,  
14 and one hundred eleven thousand one hundred twenty-two dollars thereafter.

15 **SECTION 4. EMERGENCY.** The sum of \$16,000 provided from the general fund for copier  
16 replacement appropriated in section 1 of this Act is declared to be an emergency measure.
