ENGROSSED SENATE BILL NO. 2005

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;
2 and to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the
3 salary of the state treasurer.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
6 as may be necessary, are appropriated out of any moneys in the general fund in the state
7 treasury, not otherwise appropriated, and from special funds derived from the strategic
8 investment and improvements fund to the state treasurer for the purpose of defraying the
9 expenses of the state treasurer, for the biennium beginning July 1, 2019, and ending June 30,
10 2021, as follows:

1 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**
2 **SIXTY-SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time
3 funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the
4 2019-21 biennium one-time funding items included in the appropriation in section 1 of this Act:

6 Information technology costs	\$0	\$35,000

8 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget
9 for the 2021-23 biennium. The state treasurer shall report to the appropriations committees of
10 the sixty-seventh legislative assembly on the use of this one-time funding for the biennium
11 beginning July 1, 2019, and ending June 30, 2021.

12 **SECTION 3. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS**
13 **FUND.** The operating expenses line item and the estimated income line item in section 1 of this
14 Act include \$35,000 from the strategic investment and improvements fund for information
15 technology costs.

16 **SECTION 4. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **54-11-13. Salary of state treasurer.**

19 The annual salary of the state treasurer is ~~ninety-six thousand nine hundred seventy-two~~
20 ~~dollars through June 30, 2016, and ninety-nine thousand eight hundred eighty-one dollars~~
21 ~~thereafter~~ one hundred seven thousand eight hundred eighty-five one hundred one thousand
22 eight hundred seventy-nine dollars through June 30, 2020, and ~~one hundred eleven thousand~~
23 ~~one hundred twenty-two~~ one hundred four thousand four hundred twenty-six dollars thereafter.
