

**FIRST ENGROSSMENT
with Conference Committee Amendments
ENGROSSED HOUSE BILL NO. 1171**

1 A BILL for an Act to create and enact two new sections to chapter 15-10 of the North Dakota
2 Century Code, relating to the development and implementation of a skilled workforce student
3 loan repayment program and a skilled workforce scholarship program; to provide continuing
4 appropriations; to provide for transfers; to provide for reports to the legislative management;
5 and to declare an emergency.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created
8 and enacted as follows:

9 **Skilled workforce student loan repayment program - Skilled workforce student loan**
10 **repayment program fund - Continuing appropriation - Report.**

- 11 1. There is created in the state treasury the skilled workforce student loan repayment
12 program fund. The fund consists of moneys transferred into the fund by the legislative
13 assembly, matching funds received, and loan repayments. Moneys in the fund are
14 appropriated to the state board of higher education on a continuing basis for the
15 purpose of distributing student loan repayment grants directly to the Bank of North
16 Dakota or other participating lender to repay outstanding student loan principal
17 balances for eligible applicants.
- 18 2. The state board of higher education shall adopt policies and procedures to develop,
19 implement, promote, and administer a skilled workforce student loan repayment
20 program in cooperation with the Bank of North Dakota and the North Dakota workforce
21 development council with the intent of attracting and retaining individuals for
22 professional or technical skills in high demand in this state.

- 1 3. The North Dakota workforce development council in cooperation with job service North
2 Dakota shall use available labor market information to determine annually the eligible
3 high-demand professional and technical skills and emerging occupations in this state.
- 4 4. The state board of higher education and the North Dakota workforce development
5 council shall compile a list of qualifying educational programs annually. Qualifying
6 education programs must pertain to the professional and technical skills and emerging
7 occupations in high demand in this state, as determined under subsection 3.
8 Qualifying educational programs may include degree or certificate programs.
- 9 5. Graduates of qualifying educational programs from institutions or entities in this state
10 may apply for the skilled workforce student loan repayment program. To be eligible to
11 receive student loan repayment grants under the program, the applicant:
- 12 a. Must have successfully completed a qualifying educational program from an
13 eligible institution of higher education;
- 14 b. Must have a student loan with the Bank of North Dakota or other participating
15 lender;
- 16 c. Following completion of a qualifying educational program, must reside and work
17 in this state in an eligible high-demand or emerging occupation; and
- 18 d. Must have met and shall continue to meet any requirements established by rule.
- 19 6. The state board of higher education shall adopt rules to ensure compliance with
20 residency and occupation requirements after completion of the qualifying educational
21 program.
- 22 7. The state board of higher education shall distribute student loan repayment grants
23 from the skilled workforce student loan repayment program fund directly to the Bank of
24 North Dakota or other participating lender to repay outstanding student loan principal
25 balances for eligible applicants. The maximum annual student loan repayment grant
26 amount for which an applicant may qualify is five thousand six hundred sixty-seven
27 dollars, or one-third of the applicant's outstanding student loan principal balance upon
28 initial application for the program, whichever is less. The maximum total student loan
29 repayment grant amount for which any applicant may qualify is seventeen thousand
30 dollars.

1 8. If an individual is receiving loan forgiveness under any other provision, the individual
2 may not receive a student loan repayment grant under this section during the same
3 application year. An individual who received a skilled workforce scholarship under
4 section 2 of this Act is not eligible for loan forgiveness under this section.

5 9. The skilled workforce student loan repayment program must be a joint public and
6 private effort. The state board of higher education shall provide one dollar of funding
7 for each one dollar of funding raised from the private sector. Any matching funds
8 received must be deposited in the skilled workforce student loan repayment program
9 fund.

10 10. The state board of higher education shall provide a biennial program report to the
11 legislative management by September first of each even-numbered year. The report
12 must include information regarding:

13 a. The eligible high-demand professional and technical skills and emerging
14 occupations;

15 b. The qualifying educational programs;

16 c. The number of applicants, eligible applicants, and applicants receiving awards;

17 d. The amount of private funding raised; and

18 e. The average and total amounts awarded under the program.

19 **SECTION 2.** A new section to chapter 15-10 of the North Dakota Century Code is created
20 and enacted as follows:

21 **Skilled workforce scholarship program - Skilled workforce scholarship fund -**

22 **Continuing appropriation - Report.**

23 1. There is created in the state treasury the skilled workforce scholarship fund. The fund
24 consists of moneys transferred into the fund by the legislative assembly, matching
25 funds received, and scholarship repayments. Moneys in the fund are appropriated to
26 the state board of higher education on a continuing basis for the purpose of providing
27 grants to institutions of higher education related to skilled workforce scholarships.
28 Institutions of higher education include institutions under the control of the state board
29 of higher education, North Dakota nonpublic accredited institutions of higher
30 education, and tribally controlled community colleges.

- 1 2. The state board of higher education shall adopt policies and procedures to develop,
2 implement, promote, and administer a skilled workforce scholarship program in
3 cooperation with the Bank of North Dakota and the North Dakota workforce
4 development council with the intent of attracting and retaining individuals for
5 professional or technical skills in high demand in this state.
- 6 3. The North Dakota workforce development council in cooperation with job service North
7 Dakota shall use available labor market information to determine annually the eligible
8 high-demand professional and technical skills and emerging occupations in this state.
- 9 4. The state board of higher education and the workforce development council shall
10 compile a list of qualifying educational programs annually. Qualifying educational
11 programs must be able to be completed within four semesters or six quarters and
12 must pertain to the professional and technical skills and emerging occupations in high
13 demand in this state, as determined under subsection 3. Qualifying educational
14 programs may include degree or certificate programs.
- 15 5. Individuals enrolled in a qualifying educational program in this state may apply for a
16 scholarship under this section. Scholarships are limited to the amount charged each
17 quarter, semester, or term by the educational institution for the tuition, fees, books, and
18 supplies required for the qualifying educational program. The scholarships are
19 intended to supplement any other scholarship or financial aid grant received by a
20 student to assist the student with the costs of the qualifying educational program. An
21 individual may not receive more than seventeen thousand dollars in total under this
22 section.
- 23 6. To be eligible for a scholarship under this section, a student must be enrolled full time
24 in an eligible program and maintain a 2.5 cumulative grade point average, based on a
25 4.0 grading system, or maintain academic progress in the program according to
26 program requirements. A student may not receive scholarships under this section for
27 more than the equivalent of four semesters of full-time enrollment or six quarters of
28 full-time enrollment.
- 29 7. Upon completion of a qualifying educational program, a student who received a
30 scholarship under this section must reside and work in this state in an eligible
31 high-demand or emerging occupation for a minimum of three years.

1 8. An individual shall repay the scholarship pursuant to the terms in the individual's
2 scholarship award agreement if the individual fails to maintain a 2.5 cumulative grade
3 point average while enrolled, discontinues attendance before the completion of any
4 semester or quarter for which a scholarship has been received, or fails to reside and
5 work in this state in an eligible high-demand or emerging occupation for at least three
6 years following degree or certificate completion.

7 9. Each quarter, semester, or term, the state board of higher education shall distribute
8 grants to institutions of higher education to provide the amounts necessary for the
9 scholarships awarded to the students enrolled in each institution.

10 10. The skilled workforce scholarship program must be a joint public and private effort.
11 The state board of higher education may distribute grants only to the extent that the
12 private sector has provided one dollar of matching funds for each dollar of funding
13 provided by the state. Any matching funds received must be deposited in the skilled
14 workforce scholarship fund.

15 11. The state board of higher education shall provide a biennial program report to the
16 legislative management by September first of each even-numbered year. The report
17 must include information regarding:

- 18 a. The eligible high-demand professional and technical skills and emerging
19 occupations;
20 b. The qualifying educational programs;
21 c. The number of applicants, eligible applicants, and applicants receiving awards;
22 d. The amount of private funding raised; and
23 e. The average and total amounts awarded under the program.

24 **SECTION 3. TRANSFER - BANK OF NORTH DAKOTA - SKILLED WORKFORCE**

25 **STUDENT LOAN REPAYMENT PROGRAM FUND.** The Bank of North Dakota shall transfer
26 the sum of \$3,000,000, or so much of the sum as may be necessary, from the Bank's current
27 earnings and undivided profits to the skilled workforce student loan repayment program fund
28 during the period beginning with the effective date of this Act, and ending June 30, 2021.

29 **SECTION 4. TRANSFER - BANK OF NORTH DAKOTA - SKILLED WORKFORCE**

30 **SCHOLARSHIP FUND.** The Bank of North Dakota shall transfer the sum of \$3,000,000, or so
31 much of the sum as may be necessary, from the Bank's current earnings and undivided profits

1 to the skilled workforce scholarship fund during the period beginning with the effective date of
2 this Act, and ending June 30, 2021.

3 **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
