## Sixty-sixth Legislative Assembly

Bismarck, February 6, 2019

The House convened at 1:00 p.m., with Speaker Klemin presiding.

The prayer was offered by Pastor Rich Wyatt, Living Hope Nazarene Church, Bismarck.

**REPORT OF PROCEDURAL COMMITTEE**

**MR. SPEAKER:** Your procedural **Committee on Delayed Bills (Rep. Pollert, Chairman)** has unanimously approved the introduction of a concurrent resolution declaring February 14, 2019, as Giving Hearts Day. Your **Committee on Delayed Bills** has by a vote of 3 YEAS, 2 NAYS, 0 ABSENT AND NOT VOTING rejected the introduction of a concurrent resolution to oppose construction of a continuous wall along the southern border, engage in consultation and cooperation with tribes directly affected by the border policy, and resume provision of federal services in Indian country.

OIL AND GAS TAX REVENUE HEDGING PILOT PROJECT - ADVISORY COMMITTEE - REPORT TO LEGISLATIVE MANAGEMENT.** During the 2019-20 interim, an advisory committee shall oversee a pilot project regarding oil and gas tax revenue hedging. At the direction of the advisory committee and using funds in an oil and gas tax revenue hedging fund at the Bank of North Dakota, the Bank shall enter swap agreements or any other hedging strategies with designated counterparts approved by the advisory committee. The members of the advisory committee are entitled to receive reimbursement for reasonable and necessary expenses incurred while performing duties for the advisory committee at the same level as state officials. The advisory committee is composed of:

1. Two members chosen by the North Dakota petroleum council;
2. The director of the office of management and budget;
3. One member of the legislative assembly appointed by the majority leader of the senate;
4. One member of the legislative assembly appointed by the majority leader of the house of representatives;
5. One representative of the Bank of North Dakota;
6. The executive director of the Indian affairs commission; and
7. The agriculture commissioner.

**SECTION 2. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may be necessary, to the Bank of North Dakota for the purpose of conducting the pilot project regarding oil and gas tax revenue hedging, for the biennium beginning July 1, 2019, and ending June 30, 2021."

- a. An amount equal to one-fourth of one percent of gross proceeds exceeding one million five hundred thousand dollars, less refunds, collected under this section each quarter into the gambling disorder treatment and prevention fund.
  - b. Seven percent of the total taxes, less refunds, collected under this section into a gaming tax allocation fund.
  - c. All remaining gaming taxes, monetary fines, and interest and penalties collected into the general fund in the state treasury.
4. Pursuant to legislative appropriation, moneys in the gaming tax allocation fund must be distributed quarterly to cities and counties in proportion to the taxes collected under this section from licensed organizations conducting games within each city, for sites within city limits, or within each county, for sites outside city limits. If a city or county allocation under this subsection is less than two hundred dollars, that city or county is not entitled to receive a payment for the quarter and the undistributed amount must be included in the total amount to be distributed to other cities and counties for the quarter."

This subdivision does not restrict the ability of an insurance carrier to void a motor vehicle liability policy for which an application was made after injury or damage occurred and does not obligate the insurance carrier to pay a claim on account of injury or damage that occurred before the application was made.
- b. The satisfaction by the insured of a judgment for ~~such~~ injury or damage is not a condition precedent to the right or duty of the insurance carrier to make payment on account of ~~such~~ the injury or damage.
- c. The insurance carrier has the right to settle any claim covered by the policy, and if ~~such~~ the settlement is made in good faith, the amount ~~thereof~~ of that settlement is deductible from the limits of liability specified in subdivision b of subsection 2 for the accident out of which ~~such~~ the claim arose.
- d. The policy, the written application ~~therefor~~ of the policy, if any, and any rider or endorsement ~~which~~ that does not conflict with the provisions of this chapter constitute the entire contract between the parties."

1. There is appropriated out of any moneys in the strategic investment and improvements fund in the state treasury, not otherwise appropriated, the sum of \$335,000, or so much of the sum as may be necessary, to the state department of health for the purpose of contracting with a third party to implement a hyperbaric oxygen therapy pilot program, for the biennium beginning July 1, 2019, and ending June 30, 2021.
2. The department shall contract with a local nonprofit entity with experience implementing studies using hyperbaric oxygen for traumatic brain injuries to conduct a pilot program for treatment of moderate to severely brain-injured North Dakotans using an established protocol of hyperbaric oxygen therapy provided by a private entity with experience in treating traumatic brain injury using medical-grade hyperbaric chambers pressurized with one hundred percent oxygen. The goals of the study include demonstrating improvement in brain-eye function using RightEye, significant improvement in quality of life of injured patients, significant improvement in cognitive abilities of injured patients, and financial savings and increased revenues for the state, including possible savings for medical assistance and workers' compensation and a positive impact on income tax revenues. The pilot program design must be established in consultation with a third-party physician.
3. During the 2019-21 biennium, the department shall make periodic reports to the legislative management on the status of the pilot program and whether the goals are being realized."
