CORRECTION AND REVISION OF THE JOURNAL

REMARKS OF REPRESENTATIVE VIGESAA

MR. SPEAKER: And members of the assembly, earlier this session we passed HCR 3032. HCR 3032 is a resolution celebrating North Dakota's relationship with the Republic of China (Taiwan). Today we have Taiwanese government officials from the Tapei Economic and Cultural Office in Denver to accept a copy of HCR 3032. Mr. Speaker, it is my honor to introduce Director General Jerry Chang, Director Jeffrey Lui and Vice Consul Shirley Chang. Mr. Speaker, with your permission I would like to read a portion of the resolution.

Now, therefore, be it resolved by the House of Representatives of North Dakota, the Senate concurring therein: That the Sixty-sixth Legislative Assembly urges North Dakota to continue its endorsement and support of the relationship and shared interests between the people of the Republic of China (Taiwan) and North Dakota and celebrate the 33rd anniversary of sister-state relations; that the Sixty-sixth Legislative Assembly endorses the signing of a Bilateral Trade Agreement between Taiwan and the United States; and that the Sixty-sixth Legislative Assembly supports Taiwan's meaningful participation in international organizations that support the health, safety, and well-being of the people of Taiwan.

Mr. Speaker and members of the assembly, thank you for the opportunity to recognize these officials and our long and important relationship with the Republic of China (Taiwan). Thank you Mr. Speaker.
