Engrossed HB 1513 repeals three existing income tax credits.

Section 2 of engrossed HB 1513 repeals the internship, workforce recruitment, and family care income tax credits. Section 1 of the bill removes corresponding references to these credits and removes two other obsolete provisions in the individual income tax law.

The repeal of the three income tax credits is expected to have a negligible fiscal impact, primarily attributable to the internship tax credit. Data show that these credits have had minimal to no usage since their enactment. If enacted, engrossed HB 1513 is expected to increase state general fund revenues by less than \$5,000 for the 2019-21 biennium.
