**15-19-06. Special funds - Deposit of collections - Transfers from general fund appropriations.**

1. A special operating fund for the center for distance education must be maintained within the state treasury and all income and fees collected by the center for distance education from any source must be remitted monthly by the director to the state treasurer and credited to the special operating fund. The director shall submit a full, minute, and itemized statement of every expenditure made during the month to the council in accordance with the rules adopted by the council, and thereafter the council may periodically authorize additional transfers to the administrative operational fund, but the balance in the fund may never exceed ten thousand dollars, and any unencumbered balance at the end of any biennium must revert to the state treasury. The administrative operational fund may not be used to pay salaries or expenses of the director.
3. The educational technology council may establish a scholarship fund to provide financial grants to students enrolled in courses offered through the center for distance education. The scholarship fund may consist only of those funds specifically appropriated by the legislative assembly and property received by the council or the center for distance education as a gift, devise, or bequest. Any gift, devise, or bequest of property received by the council or center for distance education which is designated by the council and donor for the scholarship fund must be deposited in the scholarship fund at the Bank of North Dakota. The state director of the center for distance education may draw only on the interest earned by the scholarship fund for the award of scholarships within the limits and rules adopted by the educational technology council. The interest earned by the scholarship fund is appropriated to the center for distance education.

**SECTION 4.** Section 15-20.1-26 of the North Dakota Century Code is created and enacted as follows:

**15-20.1-26. Educational technology council - Meetings - Compensation.**

1. The educational technology council is responsible for coordinating educational technology initiatives for elementary and secondary education.
2. The educational technology council consists of:
  - a. The chief information officer.
  - b. The superintendent of public instruction or the superintendent's designee.
  - c. The commissioner of higher education or the commissioner's designee.
  - d. A representative appointed by the state board for career and technical education.
  - e. A representative appointed by the governor from a list of three nominees submitted by the North Dakota association of technology leaders.
  - f. A representative appointed by the governor from a list of three nominees submitted by the North Dakota council of educational leaders.
  - g. A representative appointed by the governor from a list of three nominees submitted by the North Dakota school boards association.
  - h. A representative appointed by the governor from a list of three nominees submitted by the North Dakota association of special education directors.
  - i. A school district representative who is appointed by the governor and who represents a school district that has an enrollment in kindergarten through grade twelve of fewer than four hundred.
  - j. A school district representative who is appointed by the governor, who is licensed to teach by the educational standards and practices board, and who is employed by a public school district in this state as a classroom teacher.
  - k. The director of technology for the department of public instruction.
  - l. A representative appointed by the governor from a list of three nominees submitted by the state association of nonpublic schools.
3. The council shall select a chairman from among its members.
4. The term of office for the members appointed by the governor is four years.
5. The members of the educational technology council appointed by the governor are entitled to receive as compensation sixty-two dollars and fifty cents per day and reimbursement of expenses as provided by law for state officers while attending meetings of the council.

**SECTION 5.** Section 15-20.1-27 of the North Dakota Century Code is created and enacted as follows:

**15-20.1-27. North Dakota educational technology council - Powers and duties.**

The educational technology council shall:

1. Coordinate the use of technology and the development of technology systems to enhance educational opportunities for elementary and secondary education.
2. Cooperate with state agencies and other organizations to develop statewide educational technology systems.
3. Adopt bylaws for the conduct of its affairs.
4. Publish the informational material it deems necessary.
5. Conduct a continuing study to assess the needs, resources, and facilities that are available or which may be required to establish educational technology systems throughout the state.
6. Solicit and receive moneys from public and private sources and expend the moneys for educational technology.
7. Appoint a technology director who shall serve at the will of the council.
8. Hire the director of the center for distance education.

**SECTION 6. REPEAL.** Sections 54-59-17 and 54-59-18 of the North Dakota Century Code are repealed."

#### BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1.** A new section to chapter 32-15 of the North Dakota Century Code is created and enacted as follows:

##### Quick take eminent domain - Use - Restrictions.

1. Unless otherwise specified by law, when the state, a department or agency of the state, or a political subdivision seeks to acquire a right of way under section 16 of article I of the Constitution of North Dakota by making an offer to purchase the right of way and depositing the amount of the offer with the clerk of the district court of the county where the right of way is located, the state, department, agency, or political subdivision first shall attempt to purchase the right of way by conducting informal negotiations for not less than sixty days.
2. If informal negotiations fail, the state, department, agency, or political subdivision shall engage in formal negotiations by:

- a. Sending the landowner an appraisal and written offer for just compensation, which includes a specific description of the exact location of the right of way, by certified mail or commercial delivery requiring a signed receipt, and receiving the signed receipt or documentation of constructive notice.
  - b. Sending the landowner a written request for a meeting by certified mail or commercial delivery requiring a signed receipt if there is no agreement regarding compensation or no response to the written offer within fifteen days of receipt, and receiving the signed receipt or documentation of constructive notice.
  - c. Sending the landowner a written notice, by certified mail or commercial delivery requiring a signed receipt, of intent to take possession of the right of way if there is no agreement regarding compensation or no response to the written request for a meeting within thirty days of receipt, and receiving the signed receipt or documentation of constructive notice.
3. Any written communication to the landowner must include contact information for responding to the communication and a description of the required negotiation timeline.
  4. The state, department, agency, or political subdivision may not include or utilize any reference to quick take eminent domain during negotiations to acquire the necessary easement for a right of way. The state, department, agency, or political subdivision may take immediate possession of the right of way, but not a blanket easement, if the state, department, agency, or political subdivision:
    - a. Files an affidavit by a lawfully authorized representative which states the district has fulfilled the required negotiation steps; and
    - b. Deposits the amount of the written offer with the clerk of the district court of the county in which the right of way is located.
  5. Within thirty days after notice has been given in writing to the landowner by the clerk of the district court that a deposit has been made for the taking of a right of way as authorized in this section, the owner of the property taken may appeal to the district court by serving a notice of appeal upon the entity that acquired the land, and the matter must be tried at the next regular or special term of court with a jury unless a jury be waived, in the manner prescribed for trials under chapter 32-15.
  6. If ownership of a right of way has not terminated, ownership of a right of way acquired under this section terminates automatically when the state, department, agency, or political subdivision does not use the right of way for the purpose for which the right of way was acquired.

**SECTION 2.** Two new paragraphs to subdivision b of subsection 2 of section 61-16.1-09 of the North Dakota Century Code are created and enacted as follows:

If a court of competent jurisdiction, agency, or commission makes a determination or enters a judgment against a person for failing to substantially comply with this subdivision, the person may not use quick take eminent domain for any purpose for a period of two years from the date of the determination or judgment.

A person failing to comply substantially with this section is liable to the owner of the property taken for treble damages incurred by the owner of the property."
