4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 37-17.1-29 of the North Dakota Century Code is amended and reenacted as follows:
- 7 37-17.1-29. Firearms and dangerous weapons in emergencies.
- Notwithstanding any other law, a person acting on behalf or under the authority of the state or a political subdivision may not do any of the following during a declared emergency:
 - a. Prohibit or restrict the otherwise lawful possession, use, carrying, transfer, transportation, storage, or display of a firearm, dangerous weapon, or ammunition;
 - b. Seize or confiscate, or authorize the seizure or confiscation of, any otherwise lawfully possessed firearm, dangerous weapon, or ammunition unless the person acting on behalf of or under the authority of the state or political subdivision is defending that person or another from an assault, arresting an individual in actual possession of a firearm, dangerous weapon, or ammunition for a violation of law, or seizing or confiscating the firearm, dangerous weapon, or ammunition as evidence of a crime; or
 - c. Require registration of any firearm, <u>dangerous weapon</u>, or ammunition for which registration is not otherwise required by law.
 - 2. Subdivision a of subsection 1 as it relates to transfer of a firearm, dangerous weapon, or ammunition does not apply to the commercial sale of firearms, dangerous weapons,

- or ammunition if an authorized authority has ordered an evacuation or general closure of businesses in the affected area.
 - 3. Any individual aggrieved by a violation of this section may commence a civil action against any person who subjects the individual, or causes the individual to be subjected, to an action prohibited by this section.
 - 4. In addition to any other remedy, an individual aggrieved by the seizure or confiscation of a firearm, dangerous weapon, or ammunition in violation of this section may bring an action for the return of the firearm, dangerous weapon, or ammunition, or the value of the firearm, dangerous weapon, or ammunition, if the firearm, dangerous weapon, or ammunition is no longer available, in the district court of the county in which that individual resides, in which the firearm, dangerous weapon, or ammunition is located, or in which the seizure or confiscation occurred.
 - 5. In any action to enforce this section, the court shall award a prevailing plaintiff costs and reasonable attorney's fees.
 - 6. For purposes of this section, "dangerous weapon" and "firearm" have the same meaning as in section 62.1-01-01.
 - **SECTION 2. AMENDMENT.** Section 62.1-01-03 of the North Dakota Century Code is amended and reenacted as follows:
 - 62.1-01-03. Limitation on authority of political subdivision regarding firearms <u>and</u> <u>dangerous weapons</u>.
 - A political subdivision, including home rule cities or counties, may not enact <u>a zoning</u> ordinance or any <u>other</u> ordinance relating to the purchase, sale, ownership, possession, transfer of ownership, registration, or licensure of firearms, <u>dangerous weapons</u>, and ammunition which is more restrictive than state law. All such existing ordinances are void.
- **SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
