1 A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota
2 aeronautics commission; ~~to provide for a report;~~ and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the North Dakota aeronautics commission for the purpose of defraying the
8 expenses of the North Dakota aeronautics commission, for the biennium beginning July 1,
9 2021, and ending June 30, 2023, as follows:

10 **SECTION 2. ESTIMATED INCOME - AIRPORT INFRASTRUCTURE FUND - AIRPORT**

11 **GRANTS - EXEMPTION.** The estimated income line item in section 1 of this Act includes
12 \$20,000,000 from the airport infrastructure fund for the aeronautics commission to provide
13 grants to airports during the biennium beginning July 1, 2021, and ending June 30, 2023.
14 Section 54-44.1-11 does not apply to this funding, and any additional funds not spent by
15 June 30, 2023, must be continued into the biennium beginning July 1, 2023, and ending
16 June 30, 2025, and may be expended only for providing grants to airports.

17 ~~— **SECTION 4. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS**~~
18 ~~**FUND.** The estimated income line item in section 1 of this Act includes \$5,000,000 from the~~
19 ~~strategic investment and improvements fund for airport grant.~~

20 **SECTION 3. APPROPRIATION.** There is appropriated from federal funds, the sum of
21 \$5,000,000, or so much of the sum as may be necessary, to the state board of higher education
22 for the purpose of reconstructing the university of North Dakota's apron at the Grand Forks
23 airport, for the biennium beginning July 1, 2021, and ending June 30, 2023. This funding is
24 considered to be a one-time funding item.
