1 A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota

2 racing commission; to provide for a legislative management study; and to provide for a report.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, and from special funds derived from other income, to the
North Dakota racing commission for the purpose of defraying the expenses of the North Dakota
racing commission, for the biennium beginning July 1, 2021, and ending June 30, 2023, as

- 1 The 2021-23 biennium one-time funding amounts are not a part of the entity's base budget 2 for the 2023-25 biennium. The racing commission shall report to the appropriations committees 3 of the sixty-eighth legislative assembly on the use of this one-time funding for the biennium 4 beginning July 1, 2021, and ending June 30, 2023. 5 SECTION 3. LEGISLATIVE MANAGEMENT STUDY - RACING COMMISSION FUNDING. 6 During the 2021-22 interim, the legislative management shall consider studying funding sources 7 for the budget of the racing commission. The study must include consideration of the feasibility 8 and desirability of changing the racing commission to a special funds only budget and the effect 9 on general fund revenues. The legislative management shall report its findings and 10 recommendations, together with any legislation required to implement the recommendations, to
- 11 the sixty-eighth legislative assembly.
