- 1 A BILL for an Act to create and enact a new subdivision to subsection 2 of section 12-60-24 and
- 2 sections 43-44-09.1, 43-44-09.2, 43-44-10.1, 43-44-18, 43-44-19, 43-44-20, and 43-44-21,
- 3 relating to criminal history background checks and licensure and regulation of nutritionists and
- 4 dietitians; to amend and reenact sections 43-44-01, 43-44-02, 43-44-03, 43-44-05, 43-44-06,
- 5 43-44-07, 43-44-08, 43-44-09, 43-44-10, 43-44-12, 43-44-13, 43-44-15, 43-44-16, and 43-44-17
- 6 of the North Dakota Century Code, relating to the regulation and licensure of nutritionists and
- 7 dietitians; and to provide a penalty.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 9 SECTION 1. A new subdivision to subsection 2 of section 12-60-24 of the North Dakota
- 10 Century Code is created and enacted as follows:
- 11 The board of dietetic practice for applications for licensure or renewal under
- 12 <u>chapter 43-44, except that criminal history record checks need not be made</u>
 13 <u>unless required by the board.</u>
- 14 SECTION 2. AMENDMENT. Section 43-44-01 of the North Dakota Century Code is

16 **43-44-01. Definitions.**

- 17 As used in this chapter, unless the context or subject matter otherwise requires:
- 18 1. "Board" means the board of dietetic practice.
- <u>"Board for certification of nutrition specialists" means the entity that serves as the</u>
 <u>credentialing agency for certified nutrition specialists.</u>
- 21 <u>3.</u> <u>"Certified nutrition specialist" means an individual certified as a nutrition specialist by</u>
- 22 the board for certification of nutrition specialists that authorizes the individual to use
- 23 the title "certified nutrition specialist" and the abbreviation "CNS" to indicate the
- 24 <u>individual is a certified nutrition specialist.</u>

1	<u>4.</u>	"Commission on dietetic registration" means the credentialing agency for the academy		
2		of nutrition and dietetics.		
3	<u>5.</u>	"Degree" means a degree received from a college or university that was a United		
4		States regionally accredited body recognized by the council for higher education		
5		accreditation and the United States department of education at the time the degree		
6		was received or validated foreign equivalent.		
7	<u>6.</u>	"Dietetics" means the integration, application, and communication of practice		
8		principles derived from integrating knowledge of the food, nutrition, biochemistry,		
9		physiology, management, and behavioral and social science, business, and basic		
10		sciences to achieve and maintain the health of people by providingoptimal nutrition		
11		assessment and nutrition care servicesstatus of an individual. The primary function of		
12		the practice of dietetics is the provision of medical nutrition therapy.		
13	3.	"Dietitian" includes dietician.		
14	4.	"General nutrition services" means the counseling of individuals or groups in the		
15		selection of food to meet normal nutritional needs, and the assessment of nutritional		
16		needs of individuals or groups by planning, organizing, coordinating, and evaluating		
17		the nutritional components of community health services.		
18	5.<u>7.</u>	"Evidence-based" or "evidence-based practice" means an approach to health care		
19		through which health practitioners use the best evidence available, to make decisions		
20		for individuals, groups, and populations.		
21	<u>8.</u>	"Foreign practitioner" means an individual who holds and maintains a license in good		
22		standing to engage in the practice of dietetics and nutrition in a state or jurisdiction		
23		other than this state and who is not the subject of a pending disciplinary action in any		
24		state or jurisdiction.		
25	<u>9.</u>	a. "General nonmedical nutrition information" may include information on any of the		
26		following:		
27		(1) Principles of good nutrition, menu planning, and food preparation.		
28		(2) Food that should be included in the normal daily diet.		
29		(3) The essential nutrients needed by the human body.		
30		(4) The recommended amounts of essential nutrients in the human body.		
31		(5) The actions of nutrients in the human body.		

1		(6) The effects of deficiencies or excesses of nutrients in the human body.
2		(7) Foods, herbs, and supplements that are good sources of essential nutrients
3		in the human body.
4		b. The term does not include the provision of medical nutrition therapy.
5	<u>10.</u>	"General supervision" means the qualified supervisor is onsite and present where
6		nutrition care services are provided or is immediately available to the individual being
7		supervised by means of electronic communications and maintains continual
8		involvement in the appropriate aspects of patient care, and has primary responsibility
9		for all nutrition care services rendered by an individual.
10	<u>11.</u>	"Licensed nutritionist" means a personan individual licensed to provide general-
11		nutrition services as provided in this chapteras a nutritionist under this chapter who
12		may be referred to or hold oneself out as a nutritionist.
13	6.<u>12.</u>	"Licensed registered dietitian" means a personan individual licensed to practice
14		dietetics as provided in this chapteras a dietitian under this chapter who may be
15		referred to or hold oneself out as a dietitian, dietitian nutritionist, nutritionist, or a
16		<u>dietician</u> .
17	7.<u>13.</u>	"Medical nutrition therapy" means the provision of nutrition care services for the
18		treatment or management of a disease or medical condition. The term includes the
19		provision of any part or all of the following services:
20		a. Interpreting anthropometric, biochemical, clinical, and dietary data in acute and
21		chronic disease states and recommending or ordering nutrient needs based on
22		the dietary data, including tube feedings and parenteral nutrition.
23		b. Food and nutrient counseling, including food and prescription drug interactions.
24		c. Developing and managing food service operations, including operations for the
25		management or treatment of disease or medical conditions, with the primary
26		function of nutrition care or recommending or ordering therapeutic diets.
27		d. Medical weight control.
28	<u>14.</u>	"Medical weight control" means medical nutrition therapy for the purpose of reducing,
29		maintaining, or gaining weight.
30	<u>15.</u>	"Nonmedical weight control" means the provision of services for the purpose of
31		reducing, maintaining, or gaining weight which does not constitute the treatment of a

5		b. The term does not include the retail sale of food products or vitamins, the giving
6		of general nonmedical nutrition information, or the providing of nonmedical weight
7		control by unlicensed individuals.
8	<u>19.</u>	"Nutrition counseling" means the advice and assistance provided by a licensed
9		registered dietitian or licensed nutritionist to an individual or group on nutrition intake
10		by integrating information from the nutrition assessment with information on food and
11		other sources of nutrient and meal preparations consistent with cultural background,
12		socioeconomic status, and therapeutic needs.
13	<u>20.</u>	"Nutrition diagnosis" means identifying and labeling nutritional problems managed and
14		treated by a licensed registered dietitian or licensed nutritionist. The term does not
15		include the medical differential diagnosis of the health status of an individual.
16	<u>21.</u>	"Nutrition intervention" means purposefully planned actions and nutrition counseling
17		intended to positively change a nutrition-related behavior, risk factor, environmental
18		condition, or aspect of the health status for an individual.
19	<u>22.</u>	"Nutrition monitoring and evaluation" means identifying patient outcomes relevant to a
20		nutrition diagnosis and comparing the outcomes with the patient's previous health
21		status, intervention goals, or reference standards to determine the progress made in
22		achieving desired outcomes of nutrition care and whether planned interventions
23		should be continued or revised.
24	<u>23.</u>	"Onsite supervision" means the qualified supervisor is present in the department or
25		facility or virtual platform at which nutrition care services are provided, is immediately
26		available to the individual being supervised and maintains continual involvement in the
27		appropriate aspects of patient care, and has primary responsibility for all nutrition care
28		services rendered by an individual.
29	<u>24.</u>	"Practice of dietetics and nutrition" means the integration and application of scientific
30		principles derived from the study of food, nutrition, biochemistry, metabolism,
31		nutrigenomics, physiology, food management, and behavioral and social sciences in

1		<u>achi</u>	achieving and maintaining health throughout the life span and in providing nutrition					
2		<u>care</u>	care services in person and via telehealth, including medical nutrition therapy, for the					
3		purp	purpose of disease management and prevention, or to treat or rehabilitate an illness,

3	<u>28.</u>	"Therapeutic diet" means a diet intervention prescribed by a physician or other
4		authorized nonphysician practitioner which provides food or nutrients via oral, enteral,
5		or parenteral routes, or a combination thereof, as part of treatment of disease or
6		diagnosed clinical conditions to modify, eliminate, decrease, or increase identified
7		micronutrients and macronutrients in the diet.
8	SEC	TION 3. AMENDMENT. Section 43-44-02 of the North Dakota Century Code is
9	amende	d and reenacted as follows:
10	43-4	4-02. Board of dietetic practice - Membership - Terms - Meetings.
11	1.	The governor shall appoint a board of dietetic practice, consisting of five members, all
12		of whom must be residents of the state at the time of their appointment. The
13		personsindividuals appointed must have been engaged in the teaching or rendering of
14		dietetics or general nutrition services to the public, or in research in dietetics or
15		general nutrition services for three years immediately preceding their appointment.
16		Three board members must be licensed registered dietitians and one member must be
17		a licensed nutritionist. The members first appointed to the board need not be licensed
18		under this chapter for appointment to their first term on the board, but must possess
19		the qualifications necessary for licensure under this chapter. One member must be
20		appointed to represent consumers of health services.
21	2.	The governor, prior to September 1, 1985, shall appoint two board members for a term-
22		of one year, two for a term of two years, and one for a term of three years.
23		Appointments made thereafter are for terms of three years, but no personindividual
24		may be appointed to serve more than two consecutive full or partial terms. Terms
25		begin on the first day of September and end on the last day of August or until
26		successors are appointed. An appointment of any member to serve out the remaining
27		term of any position on the board that <u>which</u> becomes vacant must be made in the
28		same manner as the original appointment for that position.
29	3.	The governor may remove any board member for good cause after giving that
30		member a written statement of the reasons for removal and after that member has had
31		an opportunity for a hearing.

1	4.	The	board shall meet during September of each calendar year and select a	
2		cha	irperson. At least one additional meeting must be held before September of the	
3		nex	t calendar year. Other meetings may be convened at the call of the chairperson or	
4		the	written request of any two board members. All meetings of the board are open to	
5		the	public, except that the board may hold closed sessions to approve an examination,	
6		or u	pon request of an applicant who fails an examination, to prepare a response	
7		indi	cating any reason for the applicant's failurereview patient medical records, review	
8		pati	ent testimony, and for other reasons as referenced in section 44-04-19.2.

- 28 <u>check must be conducted in the manner provided in section 12-60-24. Refusal to</u>
- 29 <u>consent to a criminal history record check may constitute grounds for the board to</u>
- 30 deny licensure to an applicant. All costs associated with obtaining a background check
- 31 <u>are the responsibility of the applicant.</u>

- 1 <u>2.</u> The board may request a criminal history record check for an applicant returning to
- 2 <u>active status as a licensed registered dietitian or licensed nutritionist.</u>
