This bill establishes a Truth, Healing, and Reconciliation Commission, and Advisory Council, and authorizes the hiring of an executive director.

Although the bill does not specifically authorize payment to commission or advisory council members, the fiscal note assumes payments using the per diem rate applicable to legislators for participating in interim committee meetings pursuant to NDCC 54-03-20. The fiscal note assumes one meeting of the advisory council each year and monthly meetings of the commission. No assumption is made regarding travel expenses and they are not included. The executive director salary and other operating costs reflect the 2021-23 recommended appropriation for the Ethics Commission, used as a reasonable estimation of the costs that would be incurred to establish a new state commission with a paid director.
