Bismarck, February 4, 2021

The House convened at 1:00 p.m., with Speaker K. Koppelman presiding.

The prayer was offered by Pastor Jim Ellis, Bismarck Community Church, Bismarck.

REQUEST

REP. MAGRUM REQUESTED that amendments to HB 1175 be heard separately, which request was granted.

SIXTH ORDER OF BUSINESS

SIXTH ORDER OF BUSINESS

SPEAKER K. KOPPELMAN DEEMED approval of the amendments to HB 1205, HB 1288, HB 1296, HB 1301, HB 1352, HB 1358, HB 1464, and HB 1471.

The bill will be HB 1502.

SECTION 2. A new section to chapter 54-06 of the North Dakota Century Code is created and enacted as follows:

Prohibition on limiting hours of operation and capacity.
