## Sixty-seventh Legislative Assembly

The House convened at 1:00 p.m., with Speaker K. Koppelman presiding.

## REMARKS OF REPRESENTATIVE MOCK

**MR. SPEAKER:** Over the last sixty years North Dakota has had sixty-one boys state hockey tournaments and more than three-fourths of these tournaments have been won by a Grand Forks team, which makes it all the more surprising that it has been sixteen years since Grand Forks Central faced off against Grand Forks Red River in a championship game. In fact, at least one player in Saturday night's match had not been born the last time these two teams met in the final game of the season. But if you were anxiously awaiting the next Central vs. Red River championship showdown, your patience was rewarded on February twenty-seventh with an exhilarating title game that ended seven minutes and nineteen seconds into overtime. After scoring six goals in the previous two games, Grand Forks Central senior, forward Chase Spicer, capped off his high school hockey career in thrilling fashion. Skating two-on-two, Braden Panzer made a centering pass to Spicer who, after a quick deflection off a Red River defenseman, buried the game-winning goal deep in the net and brought the twenty-ninth boys state hockey championship home for the Grand Forks Central Knights. This year's title for Grand Forks Central is the fourth in five years and you can count on the Knights being a favorite in the 2022 season. We'd like to recognize the efforts of all teams in this year's competition: tournament runner-up, Grand Forks Red River Roughriders; third place finisher, Fargo South-Shanley Bruins; fourth place and tournament underdog, West Fargo Packers; Bismarck Century, Minot, Williston, and Bottineau-Rugby. Finally, we extend our heartfelt congratulations to the entire Grand Forks Central boys hockey team, led by Coach Grant Paranica, on this historic win.
