# REMARKS OF REPRESENTATIVE STEMEN

MR. SPEAKER: If I may, I would appreciate the opportunity to share some events from last evening. The freshmen group of the sixty-seventh legislative assembly of the great state of North Dakota will typically meet on Monday evenings to have a meal and discuss the topics of the day or week, whether those topics are related to legislative duties or not. The meals were delivered to the table and all began to enjoy what they ordered. In the midst of the conversation and partaking, one of our members began to demonstrate that something was definitely wrong. The question was asked, "Is everything okay?", to which the representative shook his head no. Another question was quickly asked, "Are you choking?", to which he nodded yes. Without hesitation, at least to the untrained eye, a fellow representative jumped to action and began administering the Heimlich maneuver. After a few minutes or so of prompt action and effort, and we all agreed it seemed like much longer than that, the obstruction was dislodged, concerns were alleviated, and we were all able to actually sit back down and finish our meals. Very carefully, I might add. We all recognized this is something that could happen to any one of us. We were all relieved that the individual who was choking was now doing okay. We all appreciated the willingness of the honorable Representative Beltz to acknowledge that something was wrong and acknowledge that he needed help. At that time, Representative Beltz became an active participant in saving his own life. With that being said, we want to take this opportunity to acknowledge that the honorable Representative Hagert, put his own concerns and doubts aside to literally come to the aid of a fellow representative and friend. Representative Hagert probably wasn't well schooled in the Heimlich and probably wasn't overly confident in his ability to administer the maneuver. What was more important than anything else, however, was that he had a willingness and a desire to help. We witnessed his help save another person's life. The freshmen class of the sixty-seventh legislative assembly of the great state of North Dakota would ask this entire body to recognize the efforts of the honorable Representative Beltz and his presence in the assembly today, and Representative Jared Hagert for his willingness to step up and help a friend in a critical time of need.

### **REMARKS OF REPRESENTATIVE DOCKTER**

**MR. SPEAKER:** It is with great honor that I rise to congratulate the Century High School Patriot girls varsity basketball team for their state championship in Class A girls basketball two days ago. But this 2021 state championship is only one of many accolades that are in order for this Century Patriot girls basketball program. First, they ended their season with a perfect record of 26-0. It is their third state championship in the last four years, and their sixth state championship in the last twelve years. It is the sixth state championship under the guidance of head coach Ron Metz, and the seventh in program history. They have participated in eight of the last eleven state championship games. The coaches and players have built a program that defines excellence. I would be remiss if I didn't also congratulate Century High School on the five additional state titles they have earned this year. Out of the eight fall sports, our Patriots took home the championship in five of them: boys crosscountry, boys soccer, football, girls swimming, and volleyball. And although they came in second place for girls golf, Patriot Hannah Herbel was the individual champion. Our football team contained eight all-state players including Cade Garcia, Lucas Schweigert, Maguire Martin, Brock Johnsen, Jacob Bosley, Thomas Jeske, Noah Schaffner (who has wisely committed to play football at the University of North Dakota), and Andrew Leingang who was named Class AAA senior player of the year. Little Tuffy Leingang grew up to be the most recruited football player in Patriots history - even more so than another famous Century alum, Carson Wentz. He, too, ultimately chose a team with North Dakota ties. He will play for former NDSU coach Chris Klieman at Kansas State next fall. Our girls swimming team won their sixth straight title with senior Lexi Duchsherer maintaining state records in the 50-yard freestyle and three different relays. Volleyball players Julia Fitterer and Logan Nissley earned all-state honors as they led the volleyball team to their seventh state title since 2011,

and Mason Kindel led the boys cross-country team to its fourth title in five years. Our soccer team, even after missing part of their season because of COVID, came back to win the state title and Nikko Helderop, Ken Brako, and Kaiden Campell earned all-state honors. Since 2015, Century High School has won six titles in girls swimming, five in volleyball, four in football, three in boys cross-country, and two in girls golf. This year our football, girls swimming, volleyball, and girls basketball teams were all undefeated. Congratulations to the Century Patriots who always embody our motto of Character, Honor, and Success.
