REMARKS OF REPRESENTATIVE SATROM

MR. SPEAKER: I am honored to represent this body on the ND Commission on Legal Defense of Indigents and I rise today to celebrate an anniversary. On this day, 58 years ago, the United States Supreme Court issued an opinion recognizing the accused's right to counsel in a criminal matter. When an individual is charged with a crime, the United States Constitution requires the state to provide lawyers to those who would otherwise not be able to afford it. Juveniles were added in 1967. North Dakota meets these constitutional mandates through the North Dakota Commission on Legal Counsel for Indigents. The Commission is the state agency that provides services to individuals when there is a constitutional, statutory or rule-based right to counsel. Mr. Speaker and members of the Assembly, please join me in recognizing the dedication and effort of the North Dakota Commission on Legal Counsel's lawyers, staff and contract attorneys who provide this service in the great state of North Dakota. We say in the pledge of allegiance at the start of every floor session the words, justice for all. We owe a heartfelt thanks to the men and women of the Commission who help to make this a reality for all North Dakota citizens.

Deciding whether to run again in 2018 was a very difficult decision, as I had been hired by Union State Bank in August of 2017. After much prayer, I decided not to run in November 2018. This turned out to be a very good decision as on December 6, 2018, I was diagnosed with stage-three colon cancer. What a shock to us, since I had zero symptoms. On December 17, 2018, I had surgery to remove the tumor along with fourteen inches of my colon and a bunch of lymph nodes. I was able to go home in time to celebrate my Savior's birth with my family, as I got out of the hospital on December 24, 2018. My first of twelve chemotherapy treatments was on January 16, 2019, and my last was on June 19, 2019. I received my treatments every other Wednesday and went home on a pump until Friday, then repeat in two weeks. Not the most fun or pleasant ordeal, but we made it. I have had follow ups every six months since, and praise the Lord, I remain cancer free at this point. If it were not for my faith, and the prayers of many, many people, I would not be here today. I was blessed to have such a great group of prayer warriors praying on my behalf. Immediately, we were at peace as we knew one of two things was going to happen. God was either going to heal me and allow me to remain here or he was going to heal me and take me home. Philippians 4:4 says, "Rejoice in the Lord always. Again I say, rejoice!" And verses 6 and 7 say, "Be anxious for nothing, but in everything, by prayer and supplication, with thanksgiving, let your requests be made known to God; and the peace of God, which surpasses all understanding, will guard your hearts and minds through Christ Jesus." This, to me, explains why I was at such peace during this whole ordeal. It wasn't me, but it was a peace given to me by my heavenly Father. Selfishly I was hoping to be healed here on earth, but I was ready if it was my time to be called home. Many people marveled at my strength during this time, but that strength did not come from me. As for strength, Philippians 4:13 is my favorite verse in the entire Bible. It says, "I can do all things through Christ who strengthens me." Wow, what a blessing this is. I am weak, but He is strong. I realize now that without faith and

prayer, I would not have had enough strength to get through the ordeal or accomplish anything. I thank God daily for the gift of faith, family, friends and prayer warriors. But most of all I am extremely thankful for the gift of salvation through grace. Speaking of prayer to you, the family of our past house members that have gone before us, please know that you are in our prayers. We pray for strength for you as you grieve the loss of your loved ones. Thank you for sharing their time and talents with the legislature and the people of the great state of North Dakota. Know that you are not alone as you grieve and adjust to life without them. To those currently serving, also know that we pray for you daily as you deal with all of the issues you must face and consider. I personally thank each and every one of you for taking the time to work so hard on behalf of your constituents and our great state. I know that your jobs are not easy ones, but again, thank you for taking the time to do the best you can. Thank you for having me here today. It has been a great honor.
