REMARKS OF REPRESENTATIVE KELLY M. ARMSTRONG United States Congress

Thank you Mr. Speaker and thank you to Majority Leader Pollert and Minority Leader Boschee. I miss you all a lot. Regardless of what side of the issue you are on, it goes to what we try to do in Washington, D.C. and that is to keep the federal government out of the way. It is fun to watch a citizen legislature do what they do best. My favorite part about North Dakota is how much access your constituents have to you and how you deal with it. You are getting into the last three weeks and getting lots of constituent interaction. Too often it is negative. Thank you. It is a lot easier to argue for state control and local control in North Dakota because you all serve here. I would rather have each of you making decisions for North Dakota regardless of what is going on in Washington, D.C. As you get through your last policy bills, I want you to know we do this a lot. My favorite thing to do in Washington, D.C. is to explain to people why what we do in North Dakota is not important to us but is important to them. I don't think there is a better place to talk about how it impacts us than the current conversation regarding climate. And I don't mean that because we don't want clean air and clean water. We do. I don't mean that because we don't want to lower carbon emissions. We do. But fundamentally, I don't know where it happened and whether it's the "chicken or the egg conversation", we have more information at the touch of our fingertips than at any time in history. When I had to write a report as a senior in high school, we would have to go to a library and actually pull like an Encyclopedia Britannica or a day old copy of the Washington Post or the Wall Street Journal and now that information is immediately available to everybody whether you're a representative of the North Dakota House or you're a senior in high school. But also at the same time I don't think our country's ever been more divided between producing and consuming states and districts. Urban areas are getting more blue. Rural areas are getting more red. Those are the facts that actually bear out. But fundamentally what we try and do is explain why what we do here is important to them. I think too often with our North Dakota sensibilities, Midwest sensibilities, where people who

don't like to brag, where people who work hard play hard -all of these things. Michael Howe is probably smiling right now because these are all things he helped me formulate running my first campaign and I used to get really grouchy about repeating things a hundred times in a row. What I've realized is, there's a lot of them that need to be repeated ten thousand times more and the reason is because what we do. We care. It doesn't matter if you're a farmer in the Red River Valley, or a rancher in southwestern North Dakota, or you work in the oil patch in Watford City or Williston. Your kids go to school there. You participate in the community there. We care about the environment. We love to hunt. We love to fish. We love all of those things. The problem is that we have this conversation and too many people driving it have never gotten dirt under their fingernails before. They've never produced something. They've never done those things and we're dealing with it on emotion instead of fact. What I mean by that is, often times this conversation really moves towards outsourcing our guilt. And that is in just getting the US fleet from one percent electric to ten percent electric which will create a rare earth metal gold rush that will deforest other places in the country. We mine zero lithium in the United States. We mine zero cobalt in the United States. We simply don't produce those things so we're going to have to import those things from our strategic adversaries. I can promise you this. A lithium mine in a developing country is not good for the environment. It is not good for the air. It's not good for the water. It's actually run mostly on diesel fuel which is somewhat counter intuitive. So how do we do this. We do it like we do it here. We actually do all of the above. We produce oil. We produced natural gas. We produce coal. We produce ethanol. We have grain farmers. We have livestock people and we do all of those things here and we do it really, really well. It's up to you to determine. You're going to continue to have those debates. We've seen it. We saw it in Texas. We saw it here. We continue to have those conversations. But the argument is better here. And it's better in a place that produces those things as opposed to coming from consuming districts who want to tell us how we live our lives, how we participate in our rural economies or how we participate in Fargo or how we participate in Bismarck. We're going to continue to fight for those things. We're going to continue to tell people and so every day when you're here and when you're frustrated and when you're grouchy and when you are sick of this place, remember it is still way better that you're touching things that are important to the North Dakota citizens as for anybody in DC, Republican or Democrat, to do that because you actually have to go back and live and work in this. -Applause-- I don't get applause breaks very often. I forgot how to pause for them. This isn't related just to the energy sector right? This is a criticism I have and I've reached out and told them this. We have an entire climate day from a new White House and they don't mention biofuels once. This isn't all Democrats by the way. I want to make sure. But there are too many on the environmental left that failed to recognize that we actually need these things. Under current technology, the technology doesn't exist to do what they want to do. The natural resources don't exist and the reality it doesn't exist and what I mean by that is the world will burn more coal next year whether we shut down every coal plant in North Dakota or not. Developing countries across the world need energy as they continue to develop and if we shrink back from that environment and we shrink back from being the statue on the hill and a shining beacon, it's not that it doesn't happen. It's that our strategic adversaries do it. Make no mistake. That's exactly what is going on. Small town western North Dakota lawyer and oil and gas guy--l've learned a lot about foreign policy and about our relationship in the world in the last two years. But I'm just telling you that if we continue to put pressure on American companies not to finance these projects, they're getting built anyway, and they're getting built by our strategic adversaries and I'm telling you our strategic adversaries do not have either our best interests at heart or those developing nations' interests at heart. Because what they do is they loan them money at loan shark rates and when they can't pay it back hey take over their ports. That is exactly how this works. That's where we're moving. That's why we're moving forward. So when we talk about those policies, I talk about energies because I can actually kind of talk about it and talk about what I know something about. But also because it's so important how we live right? You guys, are walking into a budget cycle and outside of the vast majority of the money that you are allowed to appropriate and that you have the responsibility of appropriating on behalf of North Dakotans comes from agriculture and energy. We continue to talk about diversifying our economy and we need to. But I will argue we have one of the best aviation tech industries in the country starting in Dickinson, North Dakota moving to Grand Sky in Grand Forks and Drone Focus in Fargo. Microsoft obviously has their second largest campus in the United States is in Fargo. I got to tour Al-Devron last week. Talk about a facility that has been relevant and what is going on in the world, and so as we continue to move through what can only can be described as a very trying year we need to remember that we are always better off when we are allowing you all to make the decisions for North Dakota, for the North Dakotan citizenry. We're way better for that. And I end with something, and I always do this, and I know you all are busy and I appreciate it because we understand

how to work with people with opposing viewpoints and it doesn't always feel that way. When I was here it didn't always feel that way as well. It's just so much better and closer, and you deal with issues in a way where you're actually touching legislation. I haven't touched a piece of legislation in two years. Like I have staff that helps me do this, and we go through things and what it effectuates is you lose that. By the way if you're ever trying to talk to somebody about a regulatory thing that is affecting one of your constituents would you rather call a North Dakota regulatory agency or DC regulatory agency? If you get somebody on the phone in DC on Tuesday and you call them back on Thursday, the likelihood of talking to the same person is almost zero. Here you might live next to them. You can bug them while they are mowing their lawn. It's just fundamentally easier to deal with and it's not just energy policy right, but it is how we deliver criminal justice in rural America, how we deliver addiction treatment in rural America, how we do those things. This body has been a leader on those issues at a time where it wasn't always politically popular to do those things. But how we do it and how we effectuate really good policy depends on understanding the place and where that policy is going to be delivered. And I am just telling you the vast majority of people in Washington DC, regardless of party affiliation, have no idea how we live. They have no idea how we work and they have no idea how we recreate and how we interact with our communities. So what we can do is help provide resources in a way that allows you to deliver those resources in the way that is best suited for rural western North Dakota or running between Grand Forks and Fargo in eastern North Dakota. We're going do it and we're going to keep arguing about it and we're going to keep telling them that what we do here is really important. It's really important now because you're going to have fights about how we reopen the economy coming out of this pandemic. I want every corner store to be open and functioning and not go out of business. I want students to go to school in person. But the simple fact is our economy in North Dakota doesn't work right unless the rest of the world economy is working. We just simply produce way too many things we don't consume here whether it's corn or soybeans or sugar beets in the Red River Valley, or its oil and natural gas in western North Dakota. We need the world to open up and we're going to continue to fight for smart policy that gets us where we need to go as quickly as possible because that's what we can do to help you do what you do best. So as you finish up this legislative session, I just want you to know that you all make my job a lot easier because it's a lot easier to argue for local control and it's a lot easier to argue for a limited federal government because I know the work you all do. I know better than most. I still get very sentimental when I walk into this building and I miss you all a lot and I'm going to continue to do what I can do to make your life easier. Thank you for having me and go back to work.

A state officer, head of any state department, whether elected or appointed, or state department, board, commission, committee, or agency may not employ legal counsel, and no person may act as legal counsel in any matter, action, or proceeding in which the state or any state department, board, commission, committee, or agency is interested or is a party, except upon written appointment by the attorney general. Workforce safety and insurance, the department of transportation, the state tax commissioner, the public service commission, the insurance commissioner, the agriculture commissioner, and the securities commissioner may employ attorneys to represent them. These entities shall pay the salaries and expenses of the attorneys they employ within the limits of legislative appropriations. The attorneys that represent these entities must be special assistant attorneys general appointed by the attorney general pursuant to this section. Absent good cause, the attorney general shall appoint as special assistant attorneys general licensed attorneys selected by these entities. The attorney general may revoke the appointment only for good cause or upon the request of the entity. Good cause means an inadequate level of experience, competence, or ethical standards.
- 2. The powers conferred upon special assistant attorneys general are the same as are exercised by the regular assistant attorneys general, unless the powers are limited specifically by the terms of the appointment. Except as otherwise provided by this section, an appointment is revocable at the pleasure of the attorney general. The appointment may

be made with or without compensation, and when compensation is allowed by the attorney general for services performed, the compensation must be paid out of the funds appropriated therefor.

- 3. The attorney general may require payment for legal services rendered by any assistant or special assistant attorney general to any state official, board, department, agency, or commission and those entities shall make the required payment to the attorney general. Moneys received by the attorney general in payment for legal services rendered must be deposited into the attorney general's operating fund. General fund moneys may not be utilized for the payment of legal services provided by the attorneys employed by the attorney general, except for those payments required of the department of human services, state department of health, department of environmental quality, and the state hospital.
- 4. An assistant or special assistant attorney general appointed to represent the state board of higher education or an institution under the control of the state board of higher education may access and examine any record under the control of the state board of higher education. For purposes of reviewing records under the Family Educational Rights and Privacy Act [20 U.S.C. 1232g; 34 CFR 99] or any other federal privacy law, the assistant or special assistant attorney general is considered a state educational official authorized to access student records."

- ¹ Funding is adjusted to provide salary increases of 1.5 percent on July 1, 2021, with a minimum monthly increase of \$100, and 2 percent on July 1, 2022. The House provided salary adjustments of 1.5 percent on July 1, 2021, and July 1, 2022, with a minimum monthly increase of \$100 and a maximum monthly increase of \$250.
- ² Funding for operating expenses is increased by \$1 million from the highway fund for implementation of an electronic driver's license. The Senate did not include this funding.
- ³ Funding of \$5 million from federal funds is added for the creation of a traffic management center. The Senate did not include this funding.
- ⁴ Funding from federal funds (\$18,127,139) and the highway fund (\$4,531,785) are increased for bridge rehabilitation and replacement. The Senate did not include this funding increase.
- ⁵ Funding is added from federal funds (\$4,013,578) and other funds (\$1,003,395) to provide grants for electric charging infrastructure. The Senate did not include this funding.
- ⁶ Funding for emergency road repair grants is increased by \$250,000, from \$500,000 to \$750,000, from the state disaster relief fund. The Senate provided \$500,000 from the state disaster relief fund.

This amendment also:

- Changes the requirements for emergency road repair grants to townships to
 preclude townships that have sufficient local funds from receiving a grant. The
 Senate precluded townships that have sufficient funds from any source from
 receiving a grant.
- Adds a section identifying \$5 million from federal funds for the creation of a traffic management center and authorizes the Department of Transportation to use state funds available during the 2021-23 biennium within its appropriation to match the federal funds. The Senate did not include funding for a traffic management center, but provided for a legislative study. The study section is removed.
- Creates a new section to North Dakota Century Code Chapter 24-02 relating to cooperative agreements for rest areas. The Senate did not include this section.
- Provides legislative intent that the Department of Transportation use gasoline fuel
 with 15 percent ethanol and the highest compatible percentage of biodiesel or
 renewable diesel for all department and State Fleet vehicles when these products
 are available and result in cost-savings. It also provides intent that State Fleet
 vehicles refueling at nonstate fuel sites use renewable fuels when available. The
 Senate did not include this section.

The Bank of North Dakota shall transfer the sum of \$3,000,000, or so much of the sum as may be necessary, from the Bank's current earnings and undivided profits to the skilled workforce student loan repayment fund during the biennium beginning July 1, 2021, and ending June 30, 2023.

SECTION 7. TRANSFER - BANK OF NORTH DAKOTA - SKILLED WORKFORCE SCHOLARSHIP FUND. The Bank of North Dakota shall transfer the sum of \$3,000,000, or so much of the sum as may be necessary, from the Bank's current earnings and undivided profits to the skilled workforce scholarship fund during the biennium beginning July 1, 2021, and ending June 30, 2023.

SECTION 8. EFFECTIVE DATE. Sections 1, 2, 3, 6, and 7 of this Act become effective on July 1, 2021.

SECTION 9. EFFECTIVE DATE. Sections 5 of this Act becomes effective on July 1, 2023."

Page 7, after line 11, insert:

"SECTION 12. EMERGENCY. This Act is declared to be an emergency measure."
