- 1 A BILL for an Act to amend and reenact sections 12.1-20-12.1 and 23-12-16 of the North
- 2 Dakota Century Code, relating to breastfeeding; and to provide a penalty.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 12.1-20-12.1 of the North Dakota Century Code is

5 amended and reenacted as follows:

21	3.	A personAn individual who commits a violation of subdivision a or b of subsection 1		
22		within fifty feet [15.24 meters] of or on the real property comprising a public or

- 3 4. The act of a woman discreetly breastfeeding her child is not a violation of this section.
- 4 <u>5.</u> As used in this section, "electronic means" includes images and pictures transmitted
 via electronic mail, electronic messaging, or from an electronic communications
 6 device.
- 7 SECTION 2. AMENDMENT. Section 23-12-16 of the North Dakota Century Code is
- 8 amended and reenacted as follows:
- 9 23-12-16. Right to breastfeed Penalty.
- 10 If the woman acts in a discreet and modest manner, aA womanAn individual may
- 11 breastfeed her child in any location, public or private, where the womanthe individual and child
- 12 are otherwise authorized to be. <u>Any person that prohibits or attempts to prohibit an individual</u>
- 13 <u>from breastfeeding her child, as authorized under this section, is guilty of an infraction.</u>
