- 1 A BILL for an Act to provide an appropriation for defraying the expenses of job service North
- 2 Dakota; to amend and reenact subsection 4 of section 52-06-01 of the North Dakota Century
- 3 Code, relating to conditions required to be eligible for unemployment benefits; to provide for a
- 4 statement of legislative intent; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to job service North Dakota for the purpose of defraying the expenses of job

service North Dakota, for the biennium beginning July 1, 2021, and ending June 30, 2023.

6	appropriated to job service North Dakota for the biennium beginning July 1, 2021, and ending					
7	June 30, 2023.					
8	SECTION 4. ESTIMATED INCOME - REED ACT FUNDS - UNEMPLOYMENT					
9	INSURANCE COMPUTER MODERNIZATION. The estimated income line item in section 1 of					
10	this Act includes the sum of \$10,945,126 from federal Reed Act funds made available to the					
11	state by the federal Reed Act distributions made in federal fiscal years 1957, 1958, 1999, and					
12	2002, pursuant to section 903 of the federal Social Security Act. This sum, or so much of the					
13	sum as may be necessary, is for the purpose of developing a modernization unemployment					
14	insurance computer system.					
15	SECTION 5. AMENDMENT. Subsection 4 of section 52-06-01 of the North Dakota Century					
16	Code is amended and reenacted as follows:					
17	4. The individual has been unemployed for a waiting period of one week. The executive					
18	dire	ector may suspend the waiting period duri	ng periods of time when fede	<u>eral</u>		
19	reimbursement for benefit charges incurred for the suspended waiting period is made					
20	available to the bureau. Any suspension of the waiting period applies to all new initial					
21	claims filed with an effective date within the time period in which the waiting period is					
22	suspended. No week may be counted as a week of unemployment for the purposes of					
23	this subsection:
