- 1 A BILL for an Act to amend and reenact section 39-06-01.1 of the North Dakota Century Code,
- 2 relating to cancellation of a minor's driver's license.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 39-06-01.1 of the North Dakota Century Code is

5 amended and reenacted as follows:

## 6 **39-06-01.1. Special provisions for minor operators.**

- The director shall cancel the operator's license of an individual who has committed
   acts resulting in an accumulated point total in excess of five points as provided for a
   violation under section 39-06.1-10 or has committed an alcohol-related offense or a
   drug-related offense while operating a motor vehicle, if:
- 11 a. The acts or offenses were committed while the individual was a minor; and
- b. The individual admitted the violation, was found to have committed the violation
  by the official having jurisdiction, or pled guilty to, was found guilty of, or
  adjudicated to have committed the offense.
- 15 2. <u>The director shall cancel the operator's license of an individual who has committed an</u>
- 16 <u>alcohol-related offense or a drug-related offense while operating a motor vehicle if:</u>
- 17 <u>a.</u> <u>The offense was committed while the individual was a minor;</u>
- 18 b. The individual was found to have committed the offense by the official having
  19 jurisdiction, or pled guilty to, was found guilty of, or adjudicated to have
  20 committed the offense;
- 21 <u>c.</u> <u>The offense created an imminent risk of injury to another individual;</u>
- 22 <u>d.</u> <u>A lesser penalty would be ineffective to prevent future risk to another individual;</u>
   23 <u>and</u>
- 24 e. The official having jurisdiction orders the director to cancel the operator's license.
