SB2179 creates a telehealth pilot with reimbursement parity. Under the pilot program, payment or reimbursement of expenses for covered services delivered by means of telehealth may not be less than the reimbursement of expenses for covered services that are delivered by in-person means.

The reimbursement for telehealth services under the NDPERS Health Plan are currently lower than in-person services. Sanford health estimates a .25% - .45% premium increase needed. A .45% increase would be \$6.43 per contract per month based on the \$1,428.77 premium in the executive budget. This would be a \$2,456,486 increase for the 2021-23 biennium based on the FTE count in the executive budget.
