- 2 relating to a telehealth reimbursement parity pilot project; to provide for a legislative

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** Section 26.1-36-09.17 of the North Dakota Century Code is created and 6 enacted as follows:

7 <u>Telehealth reimbursement parity - Pilot project.</u>

- 8 <u>1. Notwithstanding contrary provisions in section 26.1-36-09.15, there is created a</u>
 9 <u>telehealth reimbursement parity pilot project.</u>
- As used in this section, "telehealth" includes audio-only telephone if no other means of communications technology is available to the patient, including a lack of adequate
 broadband access, or the other means of communications technology is infeasible,
- impractical, or otherwise not medically advisable, as determined by the health care
- provider or health care facility providing telehealth services to the patient or as
- determined by another health care provider or health care facility with an existing
- 16 <u>relationship to the patent.</u>
- 17 <u>3. Under the pilot program, payment or reimbursement of expenses for covered services</u>
- delivered by means of telehealth under this section may not be less than the
- reimbursement of expenses for covered services that are delivered by in-person
- 20 <u>means.</u>

1	SECTION 2. LEGISLATIVE MANAGEMENT STUDY - TELEHEALTH COVERAGE. During
2	the 2021-22 interim, the legislative management shall study telehealth costs, services, and
3	reimbursement options. The study should include input from stakeholders, such as providers,
4	payors, and the insurance department. A goal of the study is to encourage providers and payors
5	to collaborate to find a mutually agreeable telehealth reimbursement structure. The study may
6	begin with a focus on behavioral health provided via telehealth. The legislative management
7	shall report its finding and recommendations, together with any legislation required to
8	implement the recommendations, to the sixty-eighth legislative assembly.
9	SECTION 3. EXPIRATION DATE. Section 1 of this Act is effective through July 31, 2023,
10	and after that date is ineffective.
