SEN. DWYER rose on a point of personal privilege.

REMARKS OF SENATOR DWYER

MR. PRESIDENT: When you are lucky enough to be Irish, you are lucky enough; but today I am even luckier because I get to actually talk about basketball on the 4th order!

Mr. President and members of the Senate, it is with great honor that I rise to congratulate the Century High School Patriot Girls Varsity Basketball Team for their State Championship in Class A Girls Basketball two days ago. But this 2021 State Championship is only one of many accolades that are in order for this Century Patriot Girls Basketball Program.

First, they ended their season with a perfect record of 26-0. Second, it is their third state championship in the last four years and their sixth state championship in the last 12 years. It is the sixth state championship under the guidance of head Coach Ron Metz and the seventh in program history! They have participated in 8 of the last 11 State Championship games. The coaches and players have built a program that defines excellence.

But the greatest attribute of this team is the example that these young athletes have displayed throughout their season. They never talked about a perfect record, but only going 1-0 in their next game. They never had to be gracious in defeat, because they never lost, but they were always humble in victory. They demonstrated excellence in their fundamentals, a "team first" attitude, hard work and extra effort in their play, and solid character.

They say sports reveals character as much as it builds character. This team of Century Patriots revealed character qualities that has made their parents, their school, and our community very proud.

So I am indeed honored to extend this recognition to the Century Patriot Girls Basketball State Champions of 2021. Thank you.

POINT OF PERSONAL PRIVILEGE

SEN. POOLMAN rose on a point of personal privilege.

REMARKS OF SENATOR POOLMAN

MR. PRESIDENT: I would be remiss if I didn't also congratulate Century High on the five additional state titles they have earned this year. Out of the eight fall sports, our Patriots took home the championship in five of them: boys cross country, boys soccer, football, girls swimming, and volleyball. And although they came in second place for girls golf, Patriot Hannah Herbel was the individual champion.

Our football team contained eight all-state players including Cade Garcia, Lucas Schweigert, Maguire Martin, Brock Johnsen, Jacob Bosley, Thomas Jeske, Noah Schaffner (who has wisely committed to play football at the University of North Dakota), and Andrew Leingang – who was named Class AAA Senior player of the year. Little Tuffy Leingang grew up to be the most recruited football player in Patriots history – even more so than another famous Century alum, Carson Wentz. He, too, ultimately chose a team with North Dakota ties. He will play for former NDSU coach Chris Klieman at Kansas State next fall.

Our girls swimming team won their sixth straight title with senior Lexi Duchsherer (who, mark my words, Mr. President, will be an Olympian) maintaining state records in the 50-yard freestyle and three different relays.

Volleyball players Julia Fitterer and Logan Nissley earned all-state honors as they led the volleyball team to their seventh state title since 2011, and Mason Kindel led the boys cross country team to its fourth title in five years, finishing 15 points ahead of any other team.

Our soccer team, even after missing part of their season because of COVID, came back to win the state title and Nikko Helderop, Ken Brako, and Kaiden Campell earned all-state honors.

Since 2015, Century has won six titles in girls swimming, five in volleyball, four in football, three in boys cross country, and two in girls golf. This year, our football, girls swimming, volleyball, and girls basketball teams were all undefeated. We are so proud of these kids, Mr. President, and I feel lucky to spend my days with them. Congratulations to the Century Patriots who always embody our motto of Character, Honor, and Success.

POINT OF PERSONAL PRIVILEGE

SEN. KANNIANEN rose on a point of personal privilege.

REMARKS OF SENATOR KANNIANEN

MR. PRESIDENT: Today it's my privilege to honor a special young man who is the pride of White Shield, ND. Jesse White just finished an illustrious high school basketball career in

which he recorded 2,800+ points, good for second all-time in the history of North Dakota High School Boys Basketball. During the District tournament a couple of weeks ago he surpassed Ron Waggoner of New Town (2,714 points) to move into the 2nd place position.

Considering Steve Blehm's remarkable total of 3,930 points from 1970-1973, which will probably hold up for a long time to come, reaching the second place position in state history is basically like setting a modern-day record.

And Jesse's not just a scorer. He's been stuffing the stat sheet ever since he first broke into the varsity ranks as a 7th grader. For example, in the recent District championship game win he recorded 30 points, 16 assists, 10 steals, and 8 rebounds. He plays team basketball by getting all of his teammates involved and creating opportunities for them to score as well, and he's a great defender with quick hands.

Mr. President, as much as I could go into more detail about his basketball prowess on the court, it's even more satisfying for me to talk about who he is as a person. While others over the past year or two have liked to talk about his scoring totals and how he was climbing the all-time rankings, his typical, humble reply was that those things didn't matter that much and what he really wanted and was focused on was to get to state. White Shield has never been to state in boys basketball.

Well, unfortunately for Jesse and his teammates, that dream did not come to pass, as White Shield lost the region championship game last week. However, one's character is best revealed during the trials of life, when things don't go as one had wished. As the final buzzer sounded, with his high school career now over, Jesse immediately approached opposing players and the opposing bench and began to congratulate them with handshakes and hugs, and he later could be seen signing autographs for young fans. In the face of a tough, disappointing loss, he showed true sportsmanship and class, just as he's done throughout his young life.

Jesse was named the Region 8 senior athlete of the year, and is a finalist for Mr. Basketball (the only Class B finalist).

While we look forward to watching Jesse play in the college ranks next year and continue to grow as a person, his family, friends, and others will always look back with fondness on his record-setting basketball career at White Shield high school. We congratulate Jesse White on one of the finest high school basketball careers the Great State of North Dakota has ever seen.
