Schools will utilize current licensed and credentialed staff to deliver the Computer Science and Cybersecurity courses to students. NDDPI is asking for \$2M of ESSER funds to quickly ramp up the professional development so we can credential at least one teacher per 250 students. Once credentialed, school staff will work with NDIT-EduTech or other professional development providers to remain credentialed.
