- (4) Where the fee is deposited; and
- (5) Whether the fee is critical for the budget of the agency.
- b. By October 1, 2023, each state agency that is authorized to impose more than forty fees shall submit a report to the legislative management including:
 - (1) The amount of each fee;
 - (2) When the fee was implemented;
 - (3) Why the fee is set at the specific dollar amount;
 - (4) Where the fee is deposited; and
 - (5) Whether the fee is critical for the budget of the agency.
- <u>vithin thirty days of receipt of the reports under subsection 1, the office of management and budget shall compile all of the reports into a single report and provide the report to the legislative management</u>
