Medicaid 1915(i) State Plan Amendment

During the 2019 legislative session, North Dakota lawmakers authorized the Department of Human Services to create a Medicaid 1915(i) State Plan Amendment. The amendment allows North Dakota Medicaid to pay for additional home and community-based services to support individuals with behavioral health conditions.

Based on the 2018 North Dakota Behavioral Health System Study, three keys to reforming North Dakota's behavioral Health system were identified:



Support the full Continuum of Care



Increase Community-Based ServicesPrevent



Criminal Justice Involvement for Individuals with a Behavioral Health Conditions

The implementation of the Medicaid 1915(i) State Plan Amendment supports these keys and also aligns with the 2018 North Dakota Behavioral Health System Study recommendation 12.2: Pursue 1915(i) Medicaid state plan amendments.

For individuals to be eligible to receive services reimbursed through the Medicaid 1915(i) State Plan Amendment, individuals must meet the following criteria:

- · Age 0+; and
- Currently enrolled in ND Medicaid or Medicaid Expansion; and
- · Meet Federal Poverty Level of 150% or below; and
- · Receive a WHODAS score of 50 or above; and
- Reside in and will receive services in a setting meeting the federal home and community-based setting requirements, and
- Have a diagnosis of substance use disorder, mental illness or brain injury.

The following services are approved through the 1915(i):

- · Care Coordination
- Training and Supports for Caregivers
- Community Transitional Services
- · Benefits Planning
- · Non-Medical Transportation
- · Respite
- Prevocational Training
- Supported Education
- Supported Employment
- Housing Support Services
- Peer Support
- · Family Peer Support

What is the process for receiving services under the 1915(i)?
