# ADMINISTRATIVE RULES COMMITTEE

Wednesday, September 4, 2024 Roughrider Room, State Capitol Bismarck, North Dakota

Representative Brandy Pyle, Chairman, called the meeting to order at 10:01 a.m.

It was moved by Senator Myrdal, seconded by Representative Marschall, and carried on a voice vote that the minutes of the June 13, 2024, meeting be approved as distributed.

# RETIREMENT BOARD

Ms. Rebecca Fricke, Executive Director, Public Employees Retirement System, provided testimony (Appendices  $\underline{B}$  and  $\underline{C}$ ) regarding proposed rules to be adopted for publication in January 2025. She noted:

- The Public Employees Retirement System (PERS) initially proposed a rule to define the terms "state governmental unit" and "state employer" to include only state entities that receive budgetary approval from the Legislative Assembly for purposes of determining which state entities are required to pay the actuarially determined employer contribution and which state entities' employees are eligible for the special election window and corresponding incentive.
- The Attorney General's office advised PERS the terms are defined in the North Dakota Century Code, and PERS withdrew the proposed rule, North Dakota Administrative Code Section 71-08-11-08, from consideration.
- 23 boards and commissions that the Legislative Assembly does not provide budget approval for will be affected by the rule withdrawal.
- PERS anticipates the proposed rules will be adopted as final and submitted to the Legislative Council by November 1, 2024, for a January 1, 2025, effective date.

### STATE BOARD OF DENTAL EXAMINERS

Mr. David Schaibley, Executive Director, State Board of Dental Examiners, provided testimony (<u>Appendix D</u>) regarding the October 2024 rules of the board. He noted workforce issues were significant to the rules amendment process.

# DEPARTMENT OF PUBLIC INSTRUCTION

Mr. Jim Upgren, Assistant Director, Office of School Approval and Opportunity, Department of Public Instruction, provided testimony (<u>Appendix G</u>) regarding the October 2024 rules of the department.

In response to a question from a committee member he noted the definition for "significant medical condition" was taken from Senate Bill No. 2013 (2023).

In response to questions from committee members, Ms. Mary McCarvel-O'Connor, Special Education Director, Department of Public Instruction, noted the term "direct services" refers to a professional working directly with a child and "indirect services" refers to a professional working directly with another professional.
