SB2238 relates to criminal history record checks for early childhood services providers.

SB2238 requires the department to ensure fingerprinting is readily available for an individual. This is defined as within a fifty-mile radius and within forty-eight hours of an individual scheduling a request. In order for the Department to accomplish this, forty-three finger print scanners would need to be purchased and an additional forty-three FTE's would be needed to support each live scan machine.

The Department does not currently and does not plan to collect fees for background checks.

SB2238 requires the department to make fingerprinting available with a fifty-mile radius and within forty-eight hours of a request. The Department would need to purchase 43 scanners with a total cost of \$897,969, all of which is general fund, to make available across the state. In addition, the Department will need an FTE to support the fingerprinting at each location. 43 FTE's with a total cost of \$5,720,410, all of which is general fund.

For the 2025-2027 biennium the Department of Human Services would need an appropriation increase in salaries of \$5,720,410 all of which is general fund and in operating of \$198,316, all of which is general fund.
