SB 2328 adds a weighting factor for rural schools to the school district integrated funding formula. It recalculates the school district size weighting factor for school districts that operate two plants at least fourteen miles apart.

Section 1 adds a weighting factor of 0.20 for school districts with less than 200 students enrolled, and the district consists of an area greater than 400 square miles.

Section 2 recalculates the school district size weighting factor for districts with 2 plants at least 14 miles apart that serve grades K-12 or have unduplicated grade levels. In districts with unduplicated grade levels, the elementary district would not have its enrollment imputed to a K-12 district.

Section 1 increases the school district integrated formula payment by \$15 million. This 15 million would be allocated to 21 school districts that serve less than 200 students and a land mass greater than 400 square miles. Section 2 increases the school district integrated formula payment by \$8.8 million. The 8.8 million would be allocated to 6 school districts that have 2 plants at least 14 miles apart.
