1 A BILL for an Act to amend and reenact ~~sections~~section 15-06-02, subsection 7 of section  
2 15.1-11-04, and section 54-01-13.2 of the North Dakota Century Code, relating to the  
3 composition of the county board of appraisers, required annual training, and land appraisal  
4 requirements.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** Section 15-06-02 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **15-06-02. County board of appraisers - How composed.**

9 The ~~county superintendent of schools, the~~ chairman of the board of county commissioners,  
10 and the county auditor of each county constitutes the county board of appraisers of the original  
11 grant lands of the state in their respective counties. The county director of tax equalization shall  
12 serve as an assistant in making the appraisals.

13 **SECTION 2. AMENDMENT.** Subsection 7 of section 15.1-11-04 of the North Dakota  
14 Century Code is amended and reenacted as follows:

15 7. As secretary of the county committee:

- 16 a. Provide to the public information regarding the annexation of property to another  
17 school district;
- 18 b. Provide to the public all forms necessary for the annexation of property to  
19 another school district;
- 20 c. Compile information regarding school district annexations and dissolutions and  
21 provide such information to the appropriate county committees, at the time and in  
22 the manner directed by the state board of public school education; ~~and~~

- 1           d. Compile information regarding school district annexations, reorganizations, and  
2           dissolutions, and provide such information to the state board of public school  
3           education, at the time and in the manner directed by the state board; and  
4           e. Attend annual training provided by the superintendent of public instruction and  
5           the North Dakota association of counties.

6           **SECTION 3. AMENDMENT.** Section 54-01-13.2 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8           **54-01-13.2. Appraisal.**

9           The lands to be conveyed to the United States of America and also the lands to be taken in  
10 exchange therefor, under ~~the provisions of~~ section 54-01-13.1, must be appraised by ~~the county~~  
11 ~~superintendent of schools~~, the county auditor, and the chairman of the board of county  
12 commissioners in the county wherein which the land is situated, at ~~its~~the land's fair market  
13 value, but ~~no~~ state school lands may not be appraised and valued at less than ten dollars per  
14 acre [.40 hectare]. The county director of tax equalization shall serve as an assistant in making  
15 the appraisals.
