Creates a new chapter and requires the Labor Department to issue written notice of the bill requirements to all employers in ND. Also requires the Labor Department to conduct investigations and make determinations of violations. Requires adoption an administrative procedure.

Section 1, Page 2, Lines 30-31: Requires written notice of the requirements to all employers in ND. Likely accomplished through mailings that will carry a cost.

Section 1 (34-16-05): Requires an investigation. Also requires violators to submit quarterly reports to the Labor

Department. Violations will require suspensions/revocations of business licenses in ND. Also allows employers in certain instances to request, and the Department provide, provisional licenses. Requires Labor Department to seek an injunction from an ALJ if necessary, which also carries costs that are difficult to estimate.

Section 1 (34-16-11): Requires an administrative hearing process. Like other 28-32 hearings, these cases may be appealed to the district and supreme courts. Significant litigation costs would occur for each case.
