A BILL for an Act to create and enact a new section to chapter 23-02.1 of the North Dakota

Century Code, relating to vital statistic collection; and to amend and reenact section 1-01-49

and subsection 7 of section 51-35-01 of the North Dakota Century Code, relating to the

definition of father, female, male, mother, and sex, and scrap metal dealer.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 1-01-49 of the North Dakota Century Code is amended 7 and reenacted as follows:
- 8 1-01-49. Other general definitions.
- 9 As used in this code, unless the context otherwise requires <u>or unless otherwise defined</u>:
- 10 1. "Depose" includes every mode of written statement under oath or affirmation.
- 11 2. "Executor" includes administrator and "administrator" includes executor.
- 12 3. "Father" means a parent of the male sex.
- 13 <u>4. "Female" means a girl, woman, or an individual whose biological reproductive system</u>

 14 <u>is developed to produce ova.</u>
- 15 <u>5.4.</u> "Individual" means a human being.
- 16 <u>6.5.</u> "Male" means a boy, man, or an individual whose biological reproductive system is developed to fertilize the ova of a female produce sperm.

0	shall identify each individual in the collected data set as either male or female, based solely on		
11	the individual's nonambiguous sex organs, chromosomes, and endogenous hormone profiles

7. "Scrap metal dealer" means a person, as defined in subsection 8 of section 1-01-49, engaged in the business of purchasing, selling, trading, or bartering scrap metal, and includes all employees of the scrap metal dealer.
