## **HOUSE CONCURRENT RESOLUTION NO. 3036**

- 1 A concurrent resolution urging Congress not to support legislation, or other efforts, relating to
- 2 the adoption of a Central Bank Digital Currency in the United States.
- WHEREAS, on March 9, 2022, President Joseph R. Biden issued Executive Order 14067,
- 4 Ensuring Responsible Development of Digital Assets, establishing a broad interagency effort to
- 5 study and develop a United States Central Bank Digital Currency (CBDC); and
- 6 **WHEREAS**, Executive Order 14067 established an interagency effort to develop "*Policy*"
- 7 and Actions Related to United States Central Bank Digital Currencies"; and
- 8 WHEREAS, Executive Order 14067 states, "within 180 days of the date of this order, the
- 9 Secretary of the Treasury, in consultation with the Secretary of State, the Attorney General, the
- 10 Secretary of Commerce, the Secretary of Homeland Security, the Director of the Office of
- 11 Management and Budget, the Director of National Intelligence, and the heads of other relevant
- 12 agencies, shall submit to the President a report on the future of money and payment systems";
- 13 and
- 14 WHEREAS, Executive Order 14067 states "the term 'central bank digital currency' or
- 15 'CBDC' refers to a form of digital money or monetary value, denomination in the national unit of
- 16 account, that is a direct liability of the central bank"; and
- WHEREAS, Executive Order 14067 requires the Attorney General, together with the
- 18 Secretary of the Treasury and the Chairman of the Federal Reserve, provide the President a
- 19 legislative proposal for a CBDC within 210 days of the executive order; and
- WHEREAS, The Federal Reserve Bank of New York and 10 financial institutions completed
- 21 testing of certain features related to a CBDC in 2022; and
- WHEREAS, the CBDC under development and testing pursuant to Executive Order 14067
- 23 will include programmable design features that will control the ability of a person to freely utilize
- 24 the CBDC; and

1 WHEREAS, a United States CBDC raises significant concerns over privacy for individuals 2 and businesses in North Dakota; and 3 WHEREAS, the adoption of a CBDC by the federal government would be an unacceptable 4 expansion of federal authority; and 5 WHEREAS, the adoption of a CBDC by the federal government would hand unprecedented 6 control over the lives, freedoms, choices, and sovereignty of the people of North Dakota to the 7 Federal Reserve; 8 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF 9 NORTH DAKOTA, THE SENATE CONCURRING THEREIN: 10 That the Sixty-eighth Legislative Assembly urges Congress not to support legislation, or 11 other efforts, relating to the adoption of a Central Bank Digital Currency in the United States; 12 and 13 **BE IT FURTHER RESOLVED**, that the Secretary of State forward copies of this resolution 14 to the President of the United States, the Speaker of the United States House of 15 Representatives, the Majority Leaders of the United States Senate and the United States House 16 of Representatives, the Chairman of the Federal Reserve, the Secretary of the Treasury, and 17 each member of the North Dakota Congressional Delegation.
