A bill to provide counties the option to hire a state emergency management coordinator in lieu of a local employee. This would come at a cost not to exceed 50% of the regional coordinator's salary and benefits.

## 4 - Fiscal Impact Sections Detail

The addition of paragraph 7 within Section 1 of HB 1071 would allow counties unable to hire a local county emergency manager the ability to work with the agency to provide those services through the department's regional management program. The cost to the locals is not to exceed fifty percent of the regional coordinator's salary and benefits.

This is a new program with limited applicability. We have estimated the fiscal note based on four counties being assessed 25% of a regional coordinator's salary and benefits for the 2023-25 biennium. For the 2025-27 biennium, we estimated eight counties at 25% each, however the additional funds received would reimburse the portion of salaries paid by a federal grant program. The salary used was an average of the four regional coordinators employed with the Department of Emergency Services, with no built in pay increases for future years.

Currently all counties have emergency managers. However, in the past there have been vacancies lasting several months putting the citizens at risk. We believe the assumptions to be on the higher end of realistic scenarios.

The amount of revenue is based on four counties being assessed 25% of a regional coordinator's salary and benefits for the 2023-25 biennium. For the 2025-27 biennium, we estimated eight counties at 25% each, however the additional funds received would reimburse the portion of salaries paid by a federal grant program.

There would be no additional expenditures to the state, and for the locals this program is optional. If the locals would choose to utilize the services the expenditures shown are based on four counties being assessed 25% of a regional coordinator's salary and benefits for the 2023-25 biennium. For the 2025-27 biennium, we estimated eight counties at 25% each.

Most counties in the state receive federal grant funds for this program, however some counties struggle to hire team members to fulfill NDCC 37-17.1-07.
