The House convened at 1:00 p.m., with Speaker D. Johnson presiding.

The prayer was offered by Pastor Shaun Breiland, CrossPoint Wesleyan Church, Watford City.

The roll was called and all members were present except Representative Christy.

A quorum was declared by the Speaker.

REMARKS OF REPRESENTATIVE HANSON

MR. SPEAKER: Congratulations to the Fargo North Spartans, the 2023 Class A boys basketball state champions, and to the Fargo North-South Spruins, state champs for girls hockey!

Although the Fargo North Spartans' boys basketball team is young— they only have two seniors — they took down the previously undefeated Bismarck Century team in the semi-finals to make it to the championship game. Then this past Saturday, they secured the big win against the Red River Roughriders.

Two brothers - Matthew and Jeremiah Sem — led the way, chalking up a combined 51 points in the championship game. The Spartans survived a furious comeback attempt by the Roughriders, with each team trading leads in the final few minutes of the game. After this tense back and forth, Matthew Sem clinched the deal with a slam dunk with 14 seconds remaining.

I want to extend a special congratulations to Fargo North's head coach Travis Hoeg. This his first year as head coach and he recently lost his father, so I'm sure he appreciated the strong support and sense of family among northsiders during the highs and the lows of the past few months.

Additionally, big congratulations go out to the Fargo North-South girls' hockey team, who secured another state championship the previous weekend. This is the second state title in a row for this new co-op team — whose team name is Spruins, a merger of the two schools' mascots. The heroes of that championship game were Kate McComb, who scored the game-winning goal while dealing with a skate issue just moments before, and goaltender Savannah Wuitschick who fended off 20 shots from Fargo Davies.

Congratulations to ALL the teams in these two tournaments for their hard work this season. And big cheers to my own kids' school, the Fargo North Spartans, for delivering their fifth boys basketball title for the northside - plus yet another girls hockey title along with Fargo South!

REMARKS OF REPRESENTATIVE ISTA

And congratulations, too, to Coach Kirby Krefting and the Red River boys basketball team for their outstanding runner-up finish this season. Your community is very proud of all you've achieved.

SIXTH ORDER OF BUSINESS

SPEAKER D. JOHNSON DEEMED approval of the amendments to HCR 3019, HCR 3020, HCR 3024, HCR 3031, and HCR 3033.

HCR 3019, HCR 3020, HCR 3024, HCR 3031, and HCR 3033, as amended, were placed on the Eleventh order of business on the calendar for the succeeding legislative day.

SECOND READING OF HOUSE AND SENATE RESOLUTIONS ON CONSENT CALENDAR

HCR 3022: A concurrent resolution directing the Legislative Management to consider studying and clarifying the roles of the State Board of Public School Education, the Superintendent of Public Instruction, the boards of public school districts, and the North Dakota High School Activities Association, as they relate to proper spectator conduct, including the clarification of expectations and consequences for violating those expectations, and the promotion of good sportsmanship and good citizenship, including embracing diversity.

HCR 3023: A concurrent resolution directing the Legislative Management to consider studying admission to the bar of this state by diploma privilege, including an examination of the barriers to retaining University of North Dakota law graduates in the state; an evaluation of the functionality of Wisconsin's diploma privilege, including any problems caused by diploma privilege; a risk assessment of the potential for decreased quality in the practice of law and increased client complaints against attorneys; an evaluation of alternative models, including apprenticeships, that may be used to determine attorney competence; and an examination of the University of North Dakota internal models of assessment that may be used to demonstrate attorney competence.

HCR 3025: A concurrent resolution directing the Legislative Management to consider studying the feasibility and desirability of renovating and constructing an addition to the Liberty Memorial Building or constructing a new building on the grounds of the state Capitol to serve as a new Supreme Court building.

HCR 3034: A concurrent resolution directing the Legislative Management to consider studying sustainable energy policies to maximize the economic viability of existing energy sources, assess future demands on electricity in the state, and determine the feasibility of advanced nuclear energy development and transmission in the state.

SCR 4008: A concurrent resolution urging the Postmaster General of the United States Postal Service to issue a postage stamp commemorating Theodore Roosevelt and the opening of the Theodore Roosevelt Presidential Library.

SCR 4016: A concurrent resolution directing the Legislative Management to consider studying the availability of adequately accessible housing in the state for individuals with mobility impairments or physical disabilities.
