REMARKS OF REPRESENTATIVE PYLE

MR. SPEAKER: Thank you, Mr. Speaker.

Members of the assembly, this past Saturday was the final state b tournament of the two-class athletic system, as it will change next year. In the final game of the season, Central Cass beat Shiloh Christian 61 to 44.

In their final win, the Central Cass Boys Basketball team accomplished what few teams do on this final year. A perfect season.

A few highlights of that game include Central Cass's Junior Cole Holzer who scored 15 points, and 14 rebounds. The MVP of the State Tournament was Central Cass's own Sam Kobbervig. He scored 14 points and had 4 assists.

The team joins an elite crowd of Champions.

The last time the Central Cass Boys Basketball team won, was in 1968 and included a couple of Pyle boys. They lost 1 game that season to a class A team in MN but went on to beat the Wolford Wolves in the championship 95-77. North Dakota state Senator Ernie Pyle's sons Jerry and Bob Pyle, were on the state championship team that year. As previously stated in another 4th order announcement, the representative from district 14 was on the second-place team that year.

This year, a Pyle girl and my daughter Braiden, was one of the statisticians for the basketball season, and documented the Central Cass Boys Basketball's successful season.

The Central Cass Boys join the Central Cass Girls basketball team as state champions this year. The last time this occurred was in 1993-1994.

To the coaches and young members of this extraordinary team- Chase, Carter, Sam, Mason, Owen, Cole, Jace, Carter, Eli, Brodie, Jacob, Brayden, Colton, Jayden, and Forrest. Congratulations on an amazing season!

REMARKS OF REPRESENTATIVE LOUSER

MR. SPEAKER: During this season of championships, this body rightly acknowledges teams from our districts and their successes in high school and in some cases, college sports. Every once in awhile an individual accomplishes something extraordinary in a team sport.

Minot High School's boys basketball player Darik Dissette was named ND Mr. Basketball on Saturday, the most coveted individual award in ND high school sports. Unfortunately, for the past 31 years, the award is not announced publicly in front of the crowd at the state Class B tournament, but done in a somewhat private ceremony where there is little public awareness.

Dissette had an amazing career for the Magi at the most storied basketball program in North Dakota. He became the school's all-time scoring leader for a career, for a season average and for a single game. He's a four-year letterwinner, multiple all stater, a state champion, Gatorade and Senior Athlete of the Year, and now the school's fourth Mr. Basketball, also the most in the state and in his case, a unanimous selection of the 27 voters across the state. While the dream of repeating for both boys and girls basketball was cut short this year, it's an impressive accomplishment that the state was able to witness again this year with Central Cass.

Dissette will be staying in North Dakota and playing for the Bison next season.

While we are discussing champions, the Minot High boys swim team capped off yet another team title in swimming a few weeks ago, their sixth championship in a row and 31st overall of the 49 years swimming has been a boys sport in the state. The team was led by Powerade Swimmer of the Year Alex King, following last year's winner Grant Schaeffer, a three time state record holder in his own right. Schaeffer happens to be my nephew.

Congratulations to these successful teams and individuals and to all the champions across ND.
