The House convened at 1:00 p.m., with Speaker D. Johnson presiding.

**POINT OF PERSONAL PRIVILEGE**

**REP. OSTLIE** rose on a point of personal privilege.

**REMARKS OF REPRESENTATIVE OSTLIE**

**MR. SPEAKER:** Thank you, Mr. Speaker and members of the assembly.

Yesterday, University of Jamestown's student athlete, Mason Walters, was named the 2023 NAIA Men's Basketball Player of the Year.

In his senior year of high school, Walters led the Jamestown Blue Jays boys basketball team to an undefeated season with a 27-0 record and a Class A State championship. He was also named the 2019 North Dakota Mr. Basketball.

Following his high school career, Mason was selected as the 2019-20 GPAC Freshman of the Year. Since then, he's been the conference player of the year three times, a three-time first team NAIA All-American, and now, the national player of the year.

Despite dealing with an injury for the entire second semester, he made the most field goals in the country (347) and was first in points scored in the NAIA (904). Only ONE player in college basketball scored more points than Walters in 2022-23.

The senior and Jamestown native has been a staple of the Jimmie program for the last four years and becomes the second men's player in UJ/JC history to be named the NAIA Player of the Year.

**REMARKS OF REPRESENTATIVE LOUSER**

**MR. SPEAKER:** On Monday, I was privileged to provide some 4th order remarks that suggested that we as legislators recognize high schools (and sometimes colleges) that win championships. There was something within that statement if you caught it at the time.

At about the time we were on the floor of the House, the Minot State University women's hockey team took to the ice in Boston to play for the ACHA national championship vs. #1 ranked Liberty University. The lady Beavers fought hard and came up a goal short....finishing as the runners up with a final score of 3-2.

That night, the Beaver men played Liberty University in the semi-finals at a different rink and defeated the Flames in overtime 3-2 to advance to the title game.

The next night, the Beaver men faced off against Adrian University for the mens ACHA Division 1 title. This is no small division, it included 70 teams this year. With the lone goal scored by Josh Pederson, the Beaver men succeeded in winning their 3rd national championship in program history. Davis Sheldon was named the MVP and the Beavers finished the season undefeated at the MAYSA arena in Minot and 35-3 overall. A rivalry between a school in ND and one in Virginia is alive and thriving!

Congratulations to both Beaver men and women's hockey teams, their coaches and the administration on campus as well as the community of Minot and we look forward to more banners being hung in the hockey capital of western North Dakota in coming years!
