BILL DESCRIPTION: WSI Legislative Reports

SUMMARY OF ACTUARIAL INFORMATION: Workforce Safety & Insurance, together with its consulting actuaries, The Burkhalter Group, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The proposed legislation:

- Removes the requirement that WSI provide the Legislative Management with reports on current and completed pilot programs and compiled data relating to safety grants; and
- Removes the requirement that WSI and Office of Administrative Hearings provide the Legislative Management with quarterly updates on the statistical information regarding results under the case processing standards and policies.

FISCAL IMPACT: No fiscal impact is anticipated.
