BILL DESCRIPTION: Notification Requirements of Social Security Disability Offset

SUMMARY OF ACTUARIAL INFORMATION: Workforce Safety & Insurance, together with its consulting actuaries, The Burkhalter Group, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The proposed legislation requires WSI to provide notification via mail at different intervals to an injured worker that is subject to the SSD offset.

FISCAL IMPACT: No significant impact is anticipated.
