Most states contract their logo signing operation to a private firm. As a result, costs to the state are minimal. Minnesota and Montana have contracted out their logo sign programs. Minnesota receives revenue of approximately \$175,000 per year and Montana receives approximately \$50,000 per year. Montana's data was used as the basis for this fiscal note.

A few states own and maintain their own signs (South Dakota for example) and charge for individual signs. We have no projection of income for that example.

Based on Montana's data, we estimate we would receive approximately \$50,000 of income from the signing contractor per year. It is assumed that it would take a year to get this program place, thus only the second year of the 23-25 would see additional revenue. Starting with the 25-2 biennium, we would realize two years of revenue.
