#### **REMARKS OF MAJORITY LEADER LEFOR**

Ladies and gentlemen of the House of Representatives, it is with a great deal of gratitude, that I rise to talk about what has happened in the past thirty days.

Since the court ruling and without a stay to provide more time to address the ruling, this assembly was tasked with moving forward with legislation in a very short time frame to make sure there would be no interruption to state government and specifically the Office of Management and Budget.

With deep gratitude, to Legislative Council, management, and clerks, I thank you for your hard work and long hours. In my life, I have never seen a better run organization than that of the North Dakota Legislative Council.

You were tasked with a difficult undertaking under immense pressure. But you delivered for the people of North Dakota. You worked together as a team, and I cannot thank you enough. From the date of the ruling, legislative leaders from both parties worked closely with Legislative Council and the executive branch to follow the provisions of the ruling to reenact

SB 2015.

Another thank you to the members of the Legislative Management committee who was tasked with a difficult job of wading through potential legislation for this session. And to Chair Vigesaa and Chair Thomas and members of your committees you did outstanding work in getting these bills into the best shape they can be in a very short period of time.

In any legislative session, special or not, we ask ourselves one important question: DO OUR ACTIONS HELP GROW THIS STATE?

And even during this short period of time together, the answer is a resounding yes.

We reaffirmed a fertilizer plant incentive to assist our ag industry to enhance fertilizer production. On the books right now, is a one-to-two-billion-dollar fertilizer plant to be built in North Dakota that will help our farmers and farmers throughout the country.

We have had a robust discussion about additional tax relief which will provide a roadmap to our interim tax committees to continue the discussion to provide more tax relief to our citizens.

We reaffirmed our commitments to improve access to behavioral health specialists in western North Dakota.

We approved legislation to help offset inflation for the on-going development of career and tech academies which provide educational opportunities for our growing workforce.

We gave approval to BSC to privately raise \$8.5 million for an athletic facility on their campus.

In his message, the governor pointed out this state ranks second in providing the best infrastructure for our citizens. This is due to the continued investment by the people of North Dakota and this Legislative Assembly.

Additionally, we continue to provide a healthy environment for business development, safe communities, career opportunities, lower taxes, and less regulations.

This state is in great shape financially due to prudent budgeting and smart decisions made by the people of North Dakota and this citizen legislature.

This includes a budget stabilization fund, common schools trust fund, legacy fund and more.

These funds lower the cost of government to our taxpayers by providing earnings to help pay the bills.

A sincere thank you to our front desk for having the intelligence, experience, great attitude, and a strong work ethic to make this session go smoothly.

Thank you Ellen Letang who makes my life a lot easier by keeping me in line, on time and on task.

The Supreme Court filled its constitutional role as a check on our coequal branch of government, reminding all of us what the state constitution requires of each of us. While the specific issue this time was the single-subject rule, the Court's opinion should also highlight the broader guiding principles under which we must operate: transparency, participation, and procedural fairness.

Going forward abiding by the Court's ruling may seem like more work for this Assembly. Indeed, it may be more work. But that work is what our constitution requires and what our citizens deserve. And we have shown this week that we can do the work efficiently and effectively if we act with discipline and rigor. Thank you to our Legislative Management Committee for keeping this special session focused and limited. Thank you to Chair Thomas and Chair Vigesaa for completing your committee work in a streamlined but open process. And thank you to all members of this chamber for the restraint with which you approached the task at hand. Let us learn a lesson from this week: that if we avoid distractions and stay laser-focused on the issues that truly matter to our constituents, we can make good public policy and make it without waste or undue delay.

As we look ahead to the 2025 session, we know we will have important issues to tackle, perhaps none more important than our ongoing workforce crisis. It will be incumbent upon us to find creative solutions to this problem. While taxes are one important consideration for workers, we know families in today's economy look beyond just that single issue. That's why investments in childcare, healthcare, education, and housing must continue to be prominent in our workforce conversation. Indeed, we have already seen promising proposals in many of these areas in bill drafts prepared by some of you for consideration during this special session. I encourage you to continue your work on these proposals. And when we reconvene in 2025, my caucus will be ready, as always, to work with anyone in this Assembly as governing partners to move our great state forward.

With that, Mr. Speaker, Leader Lefor, and my House colleagues, I wish you well as fall turns to winter—regrettably, it appears, sooner than any of us would like. Thank you again for your service to this wonderful state.

This is to inform you that on October 25, 2023, I have signed the following: HB 1547.

**COMMUNICATION FROM GOVERNOR DOUG BURGUM**

Pursuant to Article V, Section 9 of the North Dakota Constitution, I have signed House Bill 1544 and filed it with the Secretary of State. I also have vetoed Section 2 of HB 1544.

The North Dakota Development Fund Inc. (NDDF) was created by the Legislature in 1991 to

provide flexible gap financing through loans and equity investments not available from most conventional lenders for the purpose of economic development in North Dakota. Any request of \$150,000 or more must be reviewed and approved by the NDDF Board of Directors.

Section 2 of HB 1544 creates an extra, unnecessary layer of red tape and bureaucracy by requiring the NDDF to obtain a recommendation for approval from the state's Clean Sustainable Energy Authority before providing financing for projects that enhance production of clean sustainable energy in North Dakota. This redundant hurdle will delay investments in North Dakota projects that have the potential to benefit our citizens and our state's economy.

With time to analyze and implement this policy change since it was approved last spring, we've determined that the desired benefits can be achieved, and the costs of this red tape can be eliminated, through mutual collaboration between NDDF and CSEA. We will work with the North Dakota Industrial Commission, which approves CSEA projects, and NDDF to ensure the respective boards have visibility and clarity of each other's processes and to ensure the most efficient and effective deployment of taxpayer dollars without slowing down projects in red tape.

For the reasons stated above, Section 2 of HB 1544 is vetoed.
