- a. Subject to legislative appropriations, each biennium during the period beginning July first of each odd-numbered year and ending December thirty-first of each even-numbered year, the state board of higher education shall award one dollar in matching grants for every two dollars raised by the institutional foundations of:
  - (1) Bismarck state college, Dakota college at Bottineau, Dickinson state university, Lake Region state college, Mayville state university, Minot state university, North Dakota state college of science, Valley City state university, and Williston state college for projects dedicated exclusively to the advancement of academics; and
  - (2) <u>University of Jamestown and university of Mary for projects</u> dedicated exclusively to student scholarships."

## STATEMENT OF PURPOSE OF AMENDMENT

This amendment adds \$2 million from the general fund for the higher education challenge grant program and expands program eligibility to include the University of Jamestown and the University of Mary.
