




Health & Human Services

SB 2124 re-defined the infrastructure of human service delivery in North Dakota



46 county social service agencies became 19 human service zones

- Zones maintained local presence with existing local offices
- Created new locally appointed Human Service Zone Boards to advise HSZ directors and serve as a liaison to the counties
- 985 county staff became employees of their zone's host county





What we do

In ND we are a state directed, human service zone administered system. Zones and HHS continue to 'Work as One' in the delivery of human services

Economic Assistance Eligibility Determination

- SNAP Supplemental Nutrition Assistance Program
- Medicaid/Healthcare coverage
- LIHEAP Energy Assistance
- Child Care Assistance
- TANF Temporary Assistance to Needy Families

Local Services

- Burial Assistance
- Zone administered Home and Community Based Services
- General Assistance
- Other locally provided services based on need and history

Child Welfare

- Assess present and impending danger
- · Safety planning
- Case management
- Assess and build parent capacities
- Provide safe supports for children and families
- Refer and broker services needed for families
- In home supports
- Parent aides
- Intake for child abuse and neglect reports

Department of Health & Human Services

- Develop and maintain program policy
- Provide program support and training
- Develop and assure compliance of program standards
- Funding of zones direct costs and a portion of indirect costs




Connecting Families to Economic Assistance is a Partnership

Human Service Zone

The applicant can contact their human service zone directly or they can simply apply online.

Determine eligibility

An eligibility worker determines eligibility.



Making ends meet is getting more difficult every month so the applicant makes the decision to reach out for help.

Gather information

The applicant can enter as much info as they can in the SPACES self-service portal.

Issue benefits

If the applicant is eligible to receive assistance, the state will issue the benefit in the appropriate manner.


HSZ Eligibility teams are the gateway to resources that help families meet basic needs

- HSZ eligibility workers review applications to determine a person's eligibility for help with:
 - Food costs and Nutrition resources (SNAP)
 - Home Energy costs (LIHEAP)
 - Child Care costs (CCAP)
 - Medicaid eligibility (Medicaid, Medicaid Expansion, Medicaid waivers, Long term care)
 - Employment, training, and financial assistance for extremely low income families (TANF)
- HSZs offer a range of local assistance programs as well, including burial assistance and general assistance




Administrative Structure for Child Protective Services


- All States are responsible for compliance with Federal and State requirements; however, they may differ in the way child welfare services are operated and delivered.
- Major CPS Functions in ND are delivered by Human Service Zones
 - Hotline to report suspected abuse or neglect
 - · Screening and determining need for response
 - Conducting assessments
 - · Safety/risk and family functioning assessments
 - Assigning cases to response track

Human Service Zones form the core of ND's Child Protective Services System





Human Service Zone Collaborations

- Child Welfare Supervision. Buffalo Bridges Child Welfare supervisors provide supervision to Central Prairie (3) and Eastern Plains (1) child welfare staff
- Delivery of Zone Administered HCBS. Agassiz Valley/Cass/ RSR working together to provide coverage for QSP (homemaker, personal care, etc..) services; targeted to rural areas where there have not been providers
- **HSZ Leadership during transitions.** Many Zone Directors have assisted other Zones after a resignation or retirement of their Director
- Support for Child Protection Services. Statewide, Child Protection Supervision has been provided across Zones when there is a turnover in staff or other capacity needs as needed; In addition, on-going CPS supervision is being provided across Zones (Northern Valley/Mountain Lakes, Dakota Central/South Country)
- **Transfer of Eligibility Workers FTEs.** RSR, South Country, and Eastern Plains have hired EWs in their zone with FTEs transferred from Cass and Grand Forks.




Establishing the funding mechanism for Human Service Zones and the delivery of social services

- 65th Legislative Assembly established the Property Tax Relief Fund to fund Social Service Redesign (SB 2206)
- OMB transfers funds into HHS' Human Services Fund (aka "457 Fund") based on budget request
 - 2017-19 \$0 M
 - 2019-21 \$173 M
 - 2021-23 \$189 M
 - 2023-25 (req) \$202 M
- The Property Tax Relief Fund was capped at \$200 M when it was first established
- The initial Human Service Zone budget request was based on actual costs of delivering County Social Services in 2017-2019



North Dakota's model of human service delivery is characterized by shared roles and responsibilities





County-delivered (state oversight responsibility)
Zone-delivered (state oversight responsibility)

The role of the Human Services Fund in funding human services

50-06-05.8. Department to assume costs of human services.

The department shall pay each human service zone's expenses for administering human services for calendar years after December 31, 2019, based on the payment amount calculated for each human service zone under chapter 50-35. The executive director of the department shall authorize expenditures from the human service finance fund to reimburse the department for the department's costs of providing human services that historically have been provided by a county or human service zone, or for a new service or program based on federal or state law.

When SB 2206 created the Human Services Fund, it was to pay for the costs of delivering human services that were previously the responsibility of the counties The 23-25 Executive

includes funding to
transfer resources for
some state-delivered
human services (that were
previously the responsibility of
counties) to the HHS
budget

This change would move us closer to a funding model that targets Human Service Fund dollars to services delivered BY Human Service Zone staff in Human Service Zones The cost of services that are delivered by HHS (i.e., "statedelivered human services") would be funded as part of the regular HHS budget

The EBR allows the use of the Human Services Fund to evolve to reflect changes in how services are delivered. It does not change the fact that the state is obligated to pay for the delivery of human services.







On the horizon for Human Service Zones and HHS



- Embracing a regional processing approach for SNAP, CCAP, LIHEAP, TANF, and Medicaid eligibility
 - Eligibility "redesign" goes live in February 2023
- Solidifying the work of new statewide teams
 - CHINS (children in need of service)
 - · Child Abuse and Neglect Hotline
 - Foster care licensing and eligibility
 - Inter-Zonal Quality Improvement peer groups
- Creating HSZ Data Snapshots key program measures of effectiveness and impact
- · Working together to problem solve
 - Guardianship | HCBS services | Case mgmt for children with complex needs | Timeliness of child protection visits | 1915(i)


