The Council advocates for policy changes that promote choice, independence, productivity and inclusion for all North Dakotans with developmental disabilities. The Council provides funding for and supports projects and activities that maximize opportunities in these areas for consumers and families.



Who we serve

The DD Council serves individuals with intellectual and developmental disabilities across the state of North Dakota and their families.



Developmental Disabilities Council Our Work: Programs & Policies created or improved



Peer to Peer Program at Bismarck State College

- 11 Peer mentors who Support 13 students with disabilities on campus
- Built from the success of Century High School's program
- Project began in 2020



National Core Indicators (NCI)

NCI measures selfdetermination, service coordination, relationships, community inclusion, rights, choices, decision-making, employment status and goals, health, welfare, and safety



Advocates Leading their Lives (ALL) statewide selfadvocacy group

Educate and train people with disabilities to be leaders and increase their advocacy



Inclusive Daycare Work

Funded 2 inclusion specialist positions. As of Nov. 2022, they have 237 interactions with 108 providers

Source of Funding

Councils receive annual allotments from Congress to administer the developmental Disabilities Act. The amount of the award varies by state and is calculated based on population and several other factors.

Activities Supported

The Council utilizes strategies such as training, educating policy makers and communities, coalition development, barrier elimination, and demonstration of new approaches to service.

- Small Innovative Grants (less than \$10,000)
- Consumer Leadership Development Funds
- Requests for Proposals
- Council Projects
- Self-Advocacy Initiatives

- Working with our DD Network partners on FASD (P&A and NDCPD)



Partners in Policymaking

Advocacy and leadership training program for people with ID/DD and their families



Continued progress requires closing the gaps

- Investigate the DSP workforce shortage crisis through a UND study and other methods
- Invest in opportunities for people with disabilities to become their own boss/own their own business
- Support of inclusion and peer-to-peer models across the lifespan
- Increase the use of Supported Decision Making
- Increase the opportunity for accessible, inclusive, and affordable housing
- Educate people during events like Disability Awareness Day, Legislative Training Institute, Health Conference, Self-Advocacy Conference
