HB 1358 allows for public charter schools to be approved and calculates the state aid for approved charter schools.

4 - Fiscal Impact Sections Detail

The fiscal impact for HB 1358 cannot be determined. This bill allows for an approval of 12 charter schools for the 2025-2027 biennium and 15 charter schools for the 2027-2029 biennium. Charter schools generate state aid by multiplying the number of students by the per pupil payment amount (2024-2025 is \$11,072). If students enroll in a charter school that were previously educated in a North Dakota public school, there would be a savings to the state. On average, a student enrolled in a public school will generate 1.20 weighted student units. Each student that enrolls in a charter school from a public school would save the state approximately \$2200 per student. This savings

will vary on the size of the school district that the student enrolls from.

If students enrolled in charter schools from private schools or home schools, there is an increase cost to the state of \$11,072 per student.

Admin rules have expense to the agency of approximately \$2500.
