HB 1451 requires ND Medicaid (including expansion) to provide comprehensive coverage of anti-obesity treatment. Of the treatments mentioned, drugs and therapy would be new costs. The notice requirements would be new costs for traditional Medicaid.

### 4 - Fiscal Impact Sections Detail

HB 1451 requires comprehensive coverage of anti-obesity medications. Currently, ND Medicaid covers a variety of oral medications for obesity. The change would be coverage of injectable and potentially branded oral anti-obesity medications.

Roughly 13 state Medicaid agencies have elected to cover anti-obesity medications (it is an optional service). Utilizing the prevalence rate of a recent new coverage state in the midwest (Kansas), the total impact for adding medications is \$4.4 million each year of the biennium, which is a 10% increase from our current budget.

The department would need to provide, in writing, notice to enrollees regarding the coverage, no later than December 31, 2025. We estimate the cost for mailing will be \$30,000.

Medicare currently covers counseling. Using the Medicare utilization billed to ND Medicaid as crossovers, this coverage would result in a \$16,000 per year increase in cost.

For the 2027-2029 biennium, the Department of Health and Human Services would need appropriation authority in the following line items;

Grants - Medical Assistance line of \$8,832,000 of which \$3,072,000 is General.
