HB 1214 changes the transportation payment calculation for school districts. The formula would include factors of square miles of the district, number of runs, and number of buildings in the district. The formula would no longer use rides as a factor.

Section 1 adds transportation into the weighting factors in the foundation aid formula.

Section 2 provides the calculation to convert the transportation information into a weighted student unit to calculate the transportation funding. Transportation funding would increase as the per pupil payment increases.

Using the 2023-2024 transportation report, school buildings, and district square milage, the increase in transportation funding would be approximately \$17.5 million for the 2025-2027 biennium. Including transportation into 15.1-27-03.1 with the other weighting factors of the funding formula would treat transportation funding and foundation aid funding similar. Transportation funding weighting factors would be included into the foundation aid formula and would be subject to local revenue reductions. Also, small school weighting factors would be multiplied to the transportation weighted student units depending on the enrollment of the district. School districts that receive no state aid in the foundation aid formula would likely no longer receive transportation funding as it would be offset by local revenue.

The fiscal note of this bill would increase with increases to the per pupil payment.

The appropriation for school district transportation is in HB 1013. The 2023-2025 appropriation is \$58.1 million. The new appropriation request would be \$68.5 million as not all \$58.1 million will be spent in the 2023-2025 biennium. The appropriation would likely need to be included with the Integrated Formula Payment appropriation.
