HB 1268 relating to mandatory drug testing by human service zones; and to provide an appropriation.

The Current Bill provides an appropriation of \$95,000 in General Fund. The Department requests the funding from this bill from Other Fund - Human Service Finance Fund (457) for \$110,800.

The Department estimates the average number parents who would be affected by this bill to be 324 per month (35%

of 925 foster care cases with a removal attributed in part to parental drug use). The fiscal note assumes an average of one unsupervised visit per month. The fiscal note also assumes an average cost per drug test of \$40, recognizing that drug testing costs can range from \$10 for basic urine screen to \$200 for hair follicle testing.

The Department request the appropriation be moved from General Funds to Other Funds- Human Service Finance Fund (457)

The total projected costs related to HB 1268 for the 2025-27 biennium is estimated to be \$310,800.

324 parents x 1 unsupervised visit per month x \$40 per drug test x 24 months = \$310,800

Currently the Executive Budget Recommendation includes \$200,000 of funding for services related to HB 1268. Therefore, the Department estimates the additional appropriation needed related to this bill would be \$110,800.

For the 2025-2027 Biennium, the Department estimates the total projected costs related to HB 1268 to be \$310,800.

The HHS Executive Budget Request includes \$200,000 of Other Funds, Human Service Finance Fund (457), in the base budget for HB 1012 for the costs of existing drug tests administered by Human Service Zones as per child welfare practice.

The fiscal note estimates an additional cost of \$110,800 that is not currently included in the HHS HB1012 Executive Budget Request. As the bill includes an appropriation of \$95,000 General fund, the department estimates an additional \$15,800 would be needed to adequately fund HB 1268.

The Department requests this increase be reflected in HB 1012, Section 7, of the Human Service Fund from \$239,112,030 to \$239,222,830 of Other funds- Human Service Finance Fund (457), an addition of the above references \$110,800.

For the 2025-2027 biennium, the Department of Health and Human Services would need appropriation authority in the following line items:
