Relating to an education savings account program for students enrolled in nonpublic schools.

## 4 - Fiscal Impact Sections Detail

The estimated number of students enrolled in nonpublic schools for the 2026-2027 school year is 7,986. The number of students that qualify under 200% of the federal poverty guidelines is 730. The estimated number of students that fall between 200% and 400% of the poverty guidelines is 3650 students, which leaves 3,606 students above the 400% poverty guideline. If all students enroll in the education savings account program, the education savings account funding would be just under \$15,000,000 assuming a per pupil payment rate of \$11,072. HB 1369 sets the per pupil rate for the 2027-2029 biennium. Currently, HB 1369 has a per pupil payment of \$11,746 for the

2026-2027 school year. This increases the cost of the program to just under \$16,000,000. NDDPI is assuming that there are no students that switch from public to private school in the estimate. When other states have implemented education savings accounts, enrollments in nonpublic schools have increased as much as 10% annually or approximately 800 students in North Dakota. If 800 students would switch from public school to nonpublic school, the increased cost for the education savings account could be an additional \$3,265,600, depending on income levels. The 800 students that may transition from the public school would decrease the spending out of foundation aid. This would result in an overall decrease of state aid to public schools in North Dakota.

The fiscal cost to administer the education savings account program between the Bank of North Dakota and the Department of Public Instruction is \$3.7 million for the 2025-2027 biennium. The costs include 2 FTEs for the Bank of North Dakota and 1 FTE for the Department of Public Instruction, a multimedia marketing campaign, a consultant to setup rules and program, audits, website updates, contracting with a 3rd party administrator for the program, and student enrollment collections with Infinite Campus. The estimated cost for the 2027-2029 biennium education savings account will be dependent on the per pupil payment rate increases, the number of students that switch to nonpublic students, and an additional \$5.155 million to administer the program.

If enacted, the total cost of the education savings account program for the 2025-2027 biennium is \$19,700,000 for administration and funding the education savings accounts. The payment rates to students depends on HB 1369. If a 3% and 3% increase is approved, students under 200% of the poverty guidelines would receive \$4,111, students between 200% and 400% would receive \$2,349 per student, and students over 400% of the poverty guidelines would receive \$1,175.

Section 2 of HB 1540 appropriates \$21.7 million for the purposes of funding the education savings account program. Of this amount, BND and NDDPI estimate administration of \$3.7 million.
